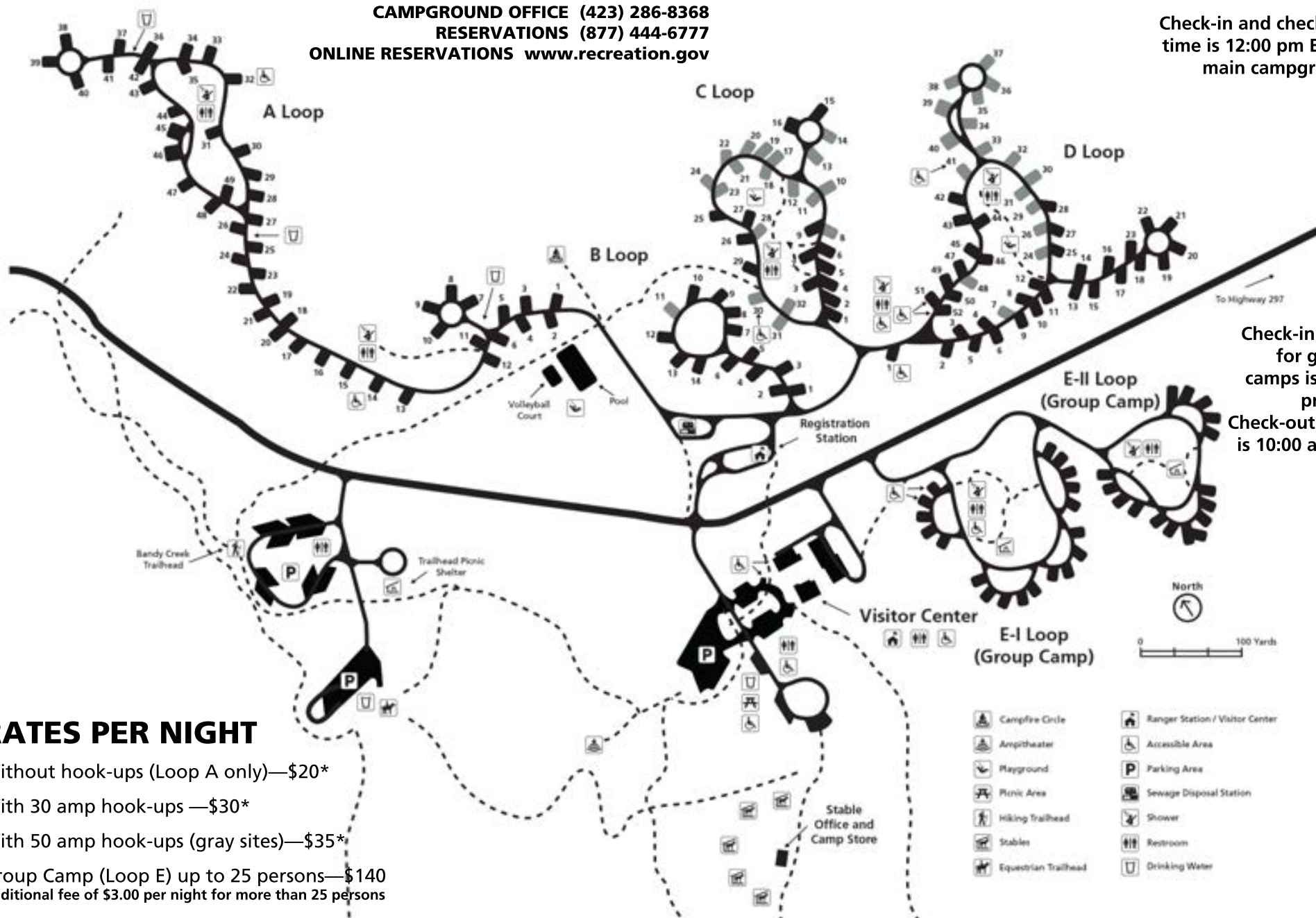

FOOD STORAGE

The entire Big South Fork NRRRA is designated for food storage restrictions.

Violation of these restrictions are prohibited and could result in property being impounded.

1. Food, garbage, and equipment used to cook or store food must be kept one or all the following:
 - sealed in a vehicle, or in a camping unit that is constructed of solid, non-pliable material; or
 - suspended at least 10 feet above the ground and 4 feet horizontally from a post, tree trunk, or other object; or
 - stored in a food storage locker.
2. Pick up all food scraps and wipe down tabletops.
3. Never pour grease and/or food waste into fire rings or into the nearby woods.



PARKING

1. Do not park on the grass or tent pad at any time. Parking is allowed on the asphalt surface only. Trailers may be parked inside the first 4 feet of the gravel pad (closest to the asphalt).
2. Under no circumstances may a camper pull forward into a site, disconnect and drive over or around the curb stop.
3. Additional parking is available at the visitor center, pool, and the bathhouses.



PETS

1. Pets must be always restrained on a leash. This includes while hiking, biking, or horseback riding.
2. Restrained pets may not be allowed access to the road or nearby campsites nor should they be left unattended. All animals must have proof of current rabies vaccinations.
3. Be considerate of other campers, prevent excessive barking and clean up waste.



CAMPSITES

1. Quiet hours are from 10:00 pm (ET) to 6:00 am (ET). Check-in and check-out time is 12:00 pm ET for the main campground. Check-in time for group camps is 2:00 pm ET and check-out time is 10:00 am ET.
2. Only one camping unit is permitted to be connected to the power and water supplies at each campsite.
3. Tents must be set up on the gravel pad only.
4. Sites may not be left unattended for more than 24 hours.
5. Driving nails, spikes or screws into trees is prohibited.
6. Firewood, regardless of the species, may only be brought into the park if the tree from which it is derived originally stood in Scott County, Fentress County, Pickett County or Morgan County, Tennessee or in McCreary County, Kentucky. Do not cut any trees, shrubs or limbs around the site that are standing and/or alive. Dead wood on the ground may be collected anywhere in the park for use as fuel for campfires.
7. The use of chainsaws anywhere in the park is prohibited.
8. Build fires only in designated grates or fire rings. Only use wood that can fit in the fire ring, otherwise it creates a fire hazard. Do not dump ashes or charcoal in the woods and never leave the fire unattended.



HYDRANT USAGE/WATER DISPOSAL

1. There are instructions on the side of the hydrant for its use. During cold weather, do not leave the water hose always connected.
2. All gray water (dishes, shower, etc.) must be disposed of at one of the bathhouses or at the dump station. Never dump gray water on the ground.
3. Water cut-off valves with blue lids are located next to each hydrant. Do not remove the cap and dump anything into it. It is for emergency water repair only.



HORSE REGULATIONS

1. Horses must be unloaded at the stables before entering the campground. Horses are not permitted in the campground or on any paved road in the park, except designated horse trails. Check with the Visitor Center or stables for approved routes.
2. Horse trailers must not be cleaned out at the campsite.
3. Drinking alcohol while on horseback is illegal.



HUNTING/ FISHING/ FIREARMS

Hunting is allowed in Big South Fork NRRRA. All Tennessee Wildlife Resources Agency (TWRA) seasons and regulations apply.

1. Possessing a loaded hunting rifle or shotgun or black powder rifle within any campsite is prohibited. Firearms are allowed only during hunting season and then must be, unloaded, cased, and possessed by someone with a valid hunting license. There are designated safety zones, check with the Visitor Center for locations.
2. Target practice of any kind and with any weapons is prohibited in the entire park. This includes BB guns, paintball guns, bows, etc.
3. Using/possessing fireworks/explosive devices in the park is illegal.
4. A valid fishing license is required to fish anywhere in the park.



BICYCLES/ MOTORIZED VEHICLES/ SKATEBOARDING/SCOOTERS

1. Bicycles must stay on pavement while in the campground.
2. Bicycles should follow all rules of the road i.e., follow traffic signs (one way etc.)
3. Bicycles may be ridden at night if they have a light in the front and a red reflective marker on the back.
4. Skating, skateboards, rollerblades, etc. are permitted only at the Bandy Creek trailhead area and bathroom parking lot.
5. Motorized vehicles not designated for highway use (i.e., ATV's, golf carts, etc) are prohibited on public roads including campground roads within the Big South Fork NRRRA. This restriction does not apply to those vehicles designed for and used by persons with a disability.



UNMANNED AIRCRAFT (DRONES)

Launching, landing, or operating an unmanned aircraft from or on lands and waters within the boundaries of the Big South Fork NRRRA is prohibited except as approved in writing by the Superintendent.
