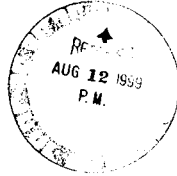

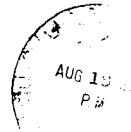

Dear Rebecca,

I was delighted to have the opportunity review and comment on your "Draft  
General Management Plan for the Booker T. Washington National Monument."

I am in favor of implementing Alternative B, but also adding the 15-acre  
boundary adjustment as a buffer against encroaching development. By upgrading the  
monument facilities, exhibits, and programs, we make a stronger commitment to  
Washington's life work - education and race relations. More people will recognize the  
park as an important stop, a place where they can walk in this man's shoes from slavery  
to leading educator.

When I first learned about this park, I was fascinated. There are numerous  
plantations here in Kentucky where one can visit and tour. But none of them offers any  
mention of the slave culture --though the free labor of Negro slaves was responsible for  
the support of those working farms. The state-owned and private plantations here give  
information mostly about the social lives of the slaveholders. Their Negro slaves remain  
invisible.

At Washington's old farm, I had the opportunity, along with my eight-year-old  
son, to have a glimpse of the life of young Booker. It was an almost spiritual experience,  
one that reached out to the millions of pained Americans who were enslaved on similar  
farms. I was impressed by how the park brought the experience of slavery down to the  
level of my young child. By enhancing this national monument, visitors might have the  
opportunity to encounter multiple complex issues such as adult and child slavery, child  
labor, slave culture, slave marriage and family, slave community, separation of slave  
families, sexual abuse of slave women, and societal repression of slaves. There are also  
other large issues that beg to be experienced from the viewpoint of Negro slaves: the  
Civil War, reconstruction, and race relations.

This important national park needs to be developed to its full potential as a tribute  
to Washington who, through his struggles and accomplishments, embodies the true spirit  
of Americans.

Thanks for the opportunity comment on this project.
