## ***HISTORY***

Between 1980-1984, various testing, excavation, and mitigation projects were undertaken by the park in association with re-routing and widening the Interpretive Loop Road in the main canyon. The project would also include construction of one parking lot between Pueblo Bonito and Chetro Kettle and another between Pueblo del Arroyo and Kin Kletso. A comfort station would also be erected adjacent to the Pueblo Bonito parking lot.

Most of the work was done by archaeologists from the Southwest Regional Office, but in one case, at small site 29SJ 626, Chaco Project personnel assisted in the work. Other areas that were excavated were 29SJ 597, 29SJ 329 and Hyde House. All sites were backfilled and recovered materials analyzed completely.

Archeological testing completed in the areas of new disturbance and construction deemed the areas unlikely to contain significant cultural resources.

The majority of the records had been retained, on long-term loan, by one of the key project personnel, Jim Bradford, in the Santa Fe office. These records were returned to the archives and cataloged in 2009.

(DF Note: In the 1980s, this project was known as the 'Interpretive Loop Road' because the majority of the work was on the 8 mile loop road. But the first portion of the project, 3+ miles, was from the Visitor Center up through Gallo Wash and included the testing/excavations of 29SJ 597, 29SJ 600, and 29SJ 603.)

**History:** This site was excavated twice. The Chaco Project tested the west portion of the site, which dates to the Pueblo I period, in July 1975. The first 44 field specimen numbers are associated with this excavation. The eastern portion of the site was excavated by a combination of Chaco Center and SWRO personnel in 1982 as part of the Loop Road Project, a salvage project prior to re-routing the loop road. The artifacts and records were commingled and so have only one accession number. Because the larger part of the excavation pertains to the Loop Road Project, all records are housed as part of this collection.

***SERIES V: LOOP ROAD/SOUTH LOOP ROAD TESTING, 1980-1984 (bulk dates: 1980-1984)***

**History:** In July-Aug 1982, NPS, acting through the Southwest Regional Office, conducted archeological test excavations at several locations within and adjacent to a new proposed interpretive loop road. The new road was based on an existing dirt road in the general vicinity of Pueblo Bonito and Pueblo del Arroyo except for minor variations. The testing program was designed to locate, identify and assess the significance of any cultural resources within or adjacent to the new road before paving began. Testing would also determine any realignment options possible if avoidance of areas was deemed necessary. Recovered materials were to be analyzed completely and all excavated areas were to be backfilled.

This collection contains the records of test excavations at various locations done under the direction of Jim Bradford in preparation for construction and paving of the new interpretive Loop Road.
