HISTORY

This collection consists of Chaco Protection Sites Program records from the Navajo Nation, a partnership created with the National Park Service in support of the Chaco Protection Sites Program legislated in 1980 (PL 96-550). Continuous cooperative agreements created annual work plans involving NPS and the Navajo Nation Chaco Protection Sites Program (NNCPSP). John R. Stein was the Program Manager for the Navajo Nation.

The primary function of NNCPSP, as implemented by the Interagency Management Group's Joint Management Plan, was to protect, preserve, and interpret sites on Navajo Nation land through field archeology, non-invasive archeology, and traditional culture, e.g., ethnography. The NNCPSP Manager and the NPS liaison positions were funded by the early '90s, with work beginning in 1993. The 1995 amendment created a funding stream via the Chaco Culture National Historical Park for NNCPSP.

<i>DESCRIPTION</i>	This collection contains records documenting, preserving and interpreting Chaco Protection Sites Program sites on Navajo Nation land and a few corresponding sites, e.g., Chaco Culture NHP sites. The collection consists of eight series and thirty subseries covering the establishment of the program; it's administration and management; documentation of CPSP sites and various pre-Columbian landscape projects with images, maps, and drawings; as well as publications, papers, and presentations by NNCPSP staff and through collaboration with Chaco Culture NHP and other colleagues. Of note, there is a linear foot of magnetic and optical media records as yet mostly non-accessed, likely containing elements of all series.

SERIES DESCRIPTIONS

SERIES I: PROGRAM OVERVIEW AND ADMINISTRATION, 1980-2008 (bulk dates: 1992-2008)

This series documents the legislative background of the Chaco Protection Sites Program (CPSP) leading up to and including the Chaco Outliers Protection Act of 1995. In 1992, a Navajo Nation CPSP Program Manager became part of the Interagency Management Group, as approximately 50% of the sites are on Navajo Nation land. With congressional approval in the same year, Navajo Nation was mandated to carry out CPSP work, with program funding administered by the National Park Service-Chaco Culture NHP by means of a cooperative agreement.

Organized into 4 subseries:

SUBSERIES A: CPSP Legislation File; SUBSERIES B: Interagency Management Group Files; SUBSERIES C: NN-NPS Cooperative Agreements; SUBSERIES D: Financial Reports and Budget Records

This series consists of four subseries documenting the legislative history, Interagency Management Group (IMG) proceedings and functions, Navajo Nation-NPS cooperative agreements, and the financial reporting and budget records stemming from the agreement. The records consist of congressional legislation, meeting agendas and minutes, agreements, correspondence, plans, account statements, expenditure reports, and funding requests.

SUBSERIES A: CPSP LEGISLATION FILES, 1980-1995 (bulk dates: 1992-1995)

This subseries documents the initial legislation P.L. 96-550 in 1980 which coordinated the activities surrounding protection sites, and the successive legislative efforts resulting in the Chaco Outliers Protection Act of 1995.

The arrangement is chronological.

This subseries consists of congressional legislation, amendments, studies, and correspondence establishing and expanding the role of the Chaco Protection Sites Program.

SUBSERIES B: INTERAGENCY MANAGEMENT GROUP FILES, 1992-2008

This subseries pertains to the files of the Interagency Management Group for CPSP and the involvement of the Navajo Nation CPSP Manager in the groups' activities and proceedings.

The arrangement is chronological.

This subseries documents IMG activities by the Navajo Nation CPSP Manager, John R. Stein, mostly in terms of the more than 20 CPSP sites on Navajo Nation land. The records consist of meeting agendas and minutes, guidelines, reports, site status lists, evaluation forms, and correspondence.

SUBSERIES C: NAVAJO NATION-NPS COOPERATIVE AGREEMENTS, 1992-2003 (bulk dates: 1992-1995)

This subseries chronicles the partnership created between the National Park Service and the Navajo Nation's Chaco Protection Site Program through continuous cooperative agreements to create annual work plans involving the park and the Navajo Nation CPSP.

The arrangement is chronological.

This subseries documents the establishment and development of the Navajo Nation-National Park Service cooperative agreement administered by NPS-Chaco Culture National Historical Park. The records consist of draft and final agreements and sub-agreements, modifications, workplans, and correspondence.

SUBSERIES D: FINANCIAL REPORTS AND BUDGET RECORDS, 1987-2008 (bulk dates: 1992-2006)

In 1992 with congressional approval Navajo Nation was mandated to carry out Chaco Protection Sites Program work, with program funding administered by the National Park Service-Chaco Culture NHP by means of a cooperative agreement. The funding allocation was based on the fiscal year.

The arrangement is chronological.

This subseries pertains to the financial administrative responsibilities and functions of the Navajo Nation-Chaco Culture NHP cooperative agreement program funding. The records consist of budget and purchase requests, account statements, expenditure reports, and correspondence.

SERIES II: PROGRAM MANAGEMENMT, 1992-2009

This series documents the management and administration of the Navajo Nation CPSP projects, program, and staff.

Organized into 6 subseries:

SUBSERIES A: Correspondence Files; SUBSERIES B: Notes and Journals; SUBSERIES C: Workplans and Update Reports; SUBSERIES D: Trainings, Seminars, and Workshops Files; SUBSERIES E: Permits, Proposals, and Contract Files; SUBSERIES F: Law Enforcement Files and Activity Reports

This series contains correspondence memos, letters, notes, and journals on the establishment and management of the NNCPSP program, projects, proposals, permits, contracts, as well as staff and law enforcement training and activities.

SUBSERIES A: CORRESPONDENCE FILES, 1992-2009

The arrangement is chronological.

This subseries contains correspondence in the form of memos and letters on the establishment and management of the NNCPSP program and projects. Additionally, it also holds requests for comment or review of publications and papers written by colleagues of NNCPSP Program Manager, John R. Stein. Most of the correspondence is incoming or outgoing from the desk of the NNCPSP Manager.

SUBSERIES B: NOTES AND JOURNALS, 1992-2009

The arrangement is chronological.

This subseries contains handwritten notes, journal entries, and project outlines by NNCPSP Manager, John R. Stein on the establishment and management of the NNCPSP program and projects.

SUBSERIES C: WORKPLANS AND UPDATE REPORTS, 1992-2009

This subseries relates to the workplans and reporting stemming from the cooperative agreements between the Navajo Nation and the National Park Service, as well as the implementation of the Joint Management Plan.

The arrangement is chronological.

This subseries documents the implementation of the Joint Management Plan as it refers to sites on Navajo Nation land, and the cooperative agreements between the Navajo Nation and the National Park Service which required workplans and reporting to continue funding allocation. The records consist of statements, workplans, reports, action plans, scope of work, and correspondence.

SUBSERIES D: TRAININGS, SEMINARS, AND WORKSHOPS FILES, 1993-2003

The arrangement is chronological.

This subseries demonstrates the training and professional development needed by Navajo Nation Chaco Protection Sites Program staff to execute their functions and enrich their understanding of the NNCPSP mandate. The records consist of workshop and seminar course work and handouts, agendas, attendee lists, correspondence, conference materials, papers, and notes.

SUBSERIES E: PERMITS, PROPOSALS, AND CONTRACT FILES, 1993-2009

The arrangement is topical and then chronological therein.

This subseries documents the various permit requests, proposals for research, and contracts generated by the NNCPSP in the function of protecting, preserving, and interpreting the sites located on Navajo Nation land. The records include permit requests, proposals, contracts, correspondence, commentary, and analyses results.

SUBSERIES F: LAW ENFORCEMENT FILES AND ACTIVITY REPORTS, 1993-1997

The arrangement is chronological.

This subseries documents the short period of time the NNCPSP Manager managed law enforcement for sites on Navajo Nation land. The records consist of reports, correspondence, training materials, and plans of operation.

SERIES III: NAVAJO NATION CHACO PROTECTION SITES PROGRAM (CPSP) PROJECTS, 1992-2004

The Navajo Nation's participation in the Chaco Protection Sites Program was primarily the implementation of the Joint Management Plan for designated sites located on Navajo Nation lands, including sites eligible for inclusion. These sites were to be protected, preserved, and interpreted through various projects with perspectives of field archeology and traditional culture in mind. The work would entail pre-stabilization documentation and contracting, limited excavation and artifact collecting, analysis, report preparation, fabric documentation and photography, mapping, and site management plans.

Organized into 3 subseries:

SUBSERIES A: Projects Organizational Files; SUBSERIES B: Phase I Sites Baseline Data Collection Files; SUBSERIES C: CPSP Sites Survey Data and Field Archeology Projects Files

This series consist of site survey forms, site drawings and maps, descriptions, management plans, ceramics counts, lists, reports, schedules, correspondence, evaluation notes, field notes, photos, and geodimeter radial survey computations pertaining to the operations of the program projects, e.g., phase I sites baseline data collection project, and various other projects based on the needs of NNCPSP sites.

SUBSERIES A: PROJECTS ORGANIZATIONAL FILES, 1994-1995

The arrangement is chronological.

This subseries documents the initial compilation of sites information, procedures, and outlines for CPSP projects. It consists of sites lists, boundary maps, acreage and ownership lists, handbook, presentation outline, and notes.

SUBSERIES B: PHASE I SITES BASELINE DATA COLLECTION FILES, 1992-1998 (bulk dates: 1994-1996)

This subseries documents the initial gathering of detailed information on sites protected, preserved, and interpreted by the NNCSPPS staff, inclusive of John R. Stein, Manager; Taft Blackhorse, NN Archeologist; and Heidi Reed, NPS Archeologist and Liaison to the NNCPSP. The first project was named Phase I Sites Baseline Data Collection and was heavily geared toward geodimeter radial surveying of the sites and database development, although some field archeology also took place. H. Reed was responsible for data collection and mapping to build the GIS database. The sites were divided into three sections: San Juan Basin, Red Mesa Valley, and Puerco River Valley.

The arrangement consists of general project files arranged chronologically, followed by an alphabetical arrangement by site name.

This subseries contains documents on the planning, reporting and evaluation of the project, as well as individual sites information. It consists of correspondence, schedules, plans, reports, evaluation notes, field notes, geodimeter radial survey computations, site and ceramics data, lists, site descriptions, maps, drawings, and photos.

SUBSERIES C: SITES SURVEY DATA AND FIELD ARCHEOLOGY PROJECTS FILES, 1993-2004

This subseries documents detailed information on Navajo Nation sites in the four corners area of the southwest, as well as some BLM and private land sites. The sites were surveyed, data gathered, and discreet projects, inclusive of traditional archeology and artifact collection, were performed on certain sites or group of site to fulfill the mandate of protection and preservation.

The arrangement is alphabetical by site name and therein chronological.

This subseries contains documents on the surveying, preservation planning, archeological work, artifact collecting, and reporting on sites. It consists of site survey forms and notes, correspondence, plans, reports, site and ceramics data, lists, site descriptions, maps, drawings, and photos.

SERIES IV: PRE-COLUMBIAN LANDSCAPE PROJECTS, 1992-2009

This series contains material on the NNCPSP's commitment to non-invasive strategies of collecting information about CPSP sites and their interconnectedness. Research emphasis was on geophysical study, mapping utilizing technologies in remote sensing, GPS, and GIS sourcing by means of strontium isotopes and trace elements (in soil, timber, lithics, ceramics, and corn studies), Navajo oral history, traditional narrative, and astronomy. Additionally, it documents stabilization of structures, pre-Columbian architecture and great houses, roads, alignments, and rock art. These projects were conducted in Chaco Canyon, Manuelito Canyon, Aztec Ruins, as well as at Newcomb, Skunk Springs, Raton Well, and Crumbled House CPSP sites.

Organized into 8 subseries:

SUBSERIES A: Chaco Core and Greater Chaco Sites Mapping Files; SUBSERIES B: Aztec Ruins Remote Sensing and Graphical Modeling Files; SUBSERIES C: Manuelito Complex Stabilization and Mapping Projects Files; SUBSERIES D: Chacoan Sites Soil, Corn, and Pollen Analyses and Studies; SUBSERIES E: Chacoan Sites Wood, Ceramics, and Lithics Analyses and Studies; SUBSERIES F: Chacoan Roads, Alignments, and Rock Art Files; SUBSERIES G: Navajo Ethnography and Traditional Narrative Files; SUBSERIES H: Papers, Articles, and Studies Used to Research Projects

The series documents pre-Columbian landscape projects using non-invasive archeology, and studies of architecture and the cultural landscape. These projects were undertaken by the Navajo Nation Chaco Protection Sites Program staff and numerous colleagues. The projects pertain to Chaco Canyon and Greater Chaco, Aztec Ruins NHP, Manuelito Canyon, various soil, corn, wood, ceramics, and lithics analyses, the Chacoan road and alignments, and Navajo ethnography. The materials consist of correspondence, proposals, studies, papers, research materials, reports, analyses, geodimetric data, outlines, notes, mapping, 3D modeling, aerial photography, images, photos, and maps.

SUBSERIES A: CHACO CORE AND GREATER CHACO SITES MAPPING FILES, 1993-2008

This subseries contains material on the Chaco Core Project, a non-invasive strategy for collecting information about sites in Chaco Canyon, Chaco Culture NHP, and the surrounding area, with focus on mapping utilizing technologies in remote sensing, GPS, and GIS sourcing to study architecture, natural and cultural resources, as well as acoustic.

The arrangement is topical, with materials pertaining to Chaco Canyon first, followed by those regarding the greater Chaco region. Each section is chronological in arrangement.

The subseries documents various undertakings pertaining to Chaco Canyon NHP and the greater Chaco region in terms of archeological and architectural mapping and modeling of sites, and employing technologies of remote sensing, GPS, and GIS. The subseries consists of correspondence, proposals, studies, papers, reports, analyses, geodimetric data, notes, aerial photography, photos, and maps.

SUBSERIES B: AZTEC RUINS REMOTE SENSING AND GRAPHICAL MODELING FILES, 1994-2006

This subseries contains material on the utilization of technologies in remote sensing and computer-generated 3D modeling to study architecture and perform non-invasive archeology on sites in Aztec Ruins NHP.

The arrangement is chronological.

The subseries documents non-invasive surface and sub-surface technology-based projects pertaining to the archeology and architecture of sites at Aztec Ruins NHP. The materials consist of correspondence, proposals, reports, plans, notes, mapping, 3D modeling, aerial photography, photos, and maps.

SUBSERIES C: MANUELITO COMPLEX STABILIZATION AND MAPPING PROJECTS FILES, 1994-2006

This subseries documents the stabilization and mapping of the Manuelito Complex, particularly the Big House ruins.

The arrangement is chronological.

This subseries pertains to the stabilization and mapping of the Manuelito Complex, particularly the Big House ruins, through erosion and stabilization studies, assessments, multispectral imaging, proposals, plans, notes, cultural resources inventory, surveys, correspondence, reports, aerial photography, photos, and maps.

SUBSERIES D: CHACOAN SITES SOIL, CORN, AND POLLEN ANALYSES AND STUDIES, 1999-2008

This subseries documents the various studies and analyses of corn, soil, and pollen in Chaco Canyon and the greater Chaco area, particularly the Chetro Ketl Field, to determine the archeological presence and origin of corn in the area.

The arrangement is chronological.

This subseries pertains to the various meetings regarding, and studies and analyses of corn, soil, and pollen in the Chaco and greater Chaco area, particularly the Chetro Ketl Field, to determine the archeological presence and origins of corn in the area. The materials consist of correspondence, proposals, studies, analyses, reports, summaries, agendas, notes, evaluations, and maps.

SUBSERIES E: CHACOAN SITES WOOD, CERAMICS, AND LITHICS ANALYSES AND STUDIES, 1995-2005

This subseries documents the various studies and analyses of wood, ceramics, and lithics in Chaco Canyon and greater Chaco area, including the Chuska Mountains.

The arrangement is chronological.

This subseries documents the various studies and analyses of wood, ceramics, and lithics in the Chaco and greater Chaco area, including the Chuska Mountains. The materials consist of correspondence, proposals, studies, papers, notes, analyses, tables and charts, and count lists.

SUBSERIES F: CHACOAN ROADS, ALIGNMENTS, AND ROCK ART FILES, 1992-2009

This subseries deals with documentation and interpretation of Chacoan roads (land lines), alignments, and rock art, as well as their interconnectedness through the study of traditional astronomy and solar-lunar observations.

The arrangement is chronological.

This subseries pertains to the documentation and interpretation of Chacoan roads (land lines), alignments, and rock art through archaeoastronomy. The materials consist of correspondence, papers, reports, notes, comments, descriptions, sketches, photos, aerial photography, and maps.

SUBSERIES G: NAVAJO ETHNOGRAPHY AND TRADITIONAL NARRATIVE FILES, 1995-2004

This subseries documents the ethnographic, oral history, and cultural research and writing primarily by Navajo Nation consultant to the Historic Preservation Department, Klara Kelley and her protege Harris Francis.

The arrangement is chronological.
