## ***HISTORY***

Paul Reiter was born in Pittsburgh, Pennsylvania on May 11, 1909, the son of a Presbyterian minister. Reiter's career in Chaco Canyon began in 1925, when he became a part-time driver for Edgar L. Hewett, director of the Museum of New Mexico and School of American Research and head of the Anthropology Department at the University of New Mexico. Reiter was a student of Hewett's first archaeological field schools at Chaco Canyon from 1929 to 1932; he then stayed on as a faculty member, serving as the assistant director of the 1933 field school. During this time, Reiter received his B.A. in Anthropology in 1931 and his M.A. in Anthropology in 1933, both from the University of New Mexico. During his time with the Chaco Canyon field schools, Reiter developed a life-long interest in the site of Chetro Ketl. Reiter conducted excavations at Chetro Ketl as a field school student and wrote his 1933 M.A. thesis on the history of the site and its excavation.

From 1931 to 1938, Reiter served as Curator of Archaeology at the Museum of New Mexico in Santa Fe. As curator, Reiter significantly improved the museum's record-keeping system and developed better methods for cataloging and tracking artifacts from Chaco and sites throughout New Mexico and the Southwest. During Hewett's time as director of the Museum of New Mexico, the School of American Research, and UNM's Department of Anthropology, the administration and staffs of all three institutions were largely intertwined. In 1938, the staffs were officially separated and Reiter left the museum to work full-time for UNM. From 1938 to 1943, Reiter was an instructor in the UNM Department of Anthropology. Reiter continued to be involved with the UNM field school throughout the 1930s and 1940s. He taught summer field schools at Chaco Canyon and Jemez, supervised the excavations of several BC sites in Chaco from 1940 to 1942, and served as director of the 1947 field school.

Reiter's later career was marked by numerous academic and professional accomplishments. From 1940 to 1941, Reiter studied in the Department of Anthropology at the University of California at Berkeley. In 1943, he became a Thaw Fellow at the Peabody Museum of Harvard University and served as a Research Associate at the Chemical Warfare Service Development Laboratory at the Massachusetts Institute of Technology. In 1946, Reiter received his Ph.D. from Harvard University. He then became an Associate Professor of Anthropology at UNM. In 1953, Reiter received a Ford Foundation Fellowship in Human Biology from the Universities of Michigan and Chicago.

Throughout his life, Paul Reiter held a variety of professional and personal interests. In addition to his work as an anthropologist, Reiter served as a building foreman for the WPA. Reiter also had an enthusiastic interest in photography and took and collected many photographs during his time with the UNM field schools and the Museum of New Mexico.

In 1933, Reiter married Winifred Stamm (1909-1990), a fellow anthropologist who also attended the early summer field schools at Chaco Canyon. Paul and Winifred Reiter had two children, Gordon and Ann Reiter. Paul Reiter died on January 10, 1953 in Ann Arbor, Michigan.

*DESCRIPTION* The Paul Reiter Collection contains material related to all aspects of Reiter's career with the University of New Mexico field schools and the Museum of New Mexico. A large part of the collection consists of the Reiter Notebooks, a set of bound volumes containing research material accumulated by Paul Reiter. These Notebooks include excavation reports, field reports, student papers, field notes, lecture notes, correspondence, artifact lists, field data forms, autographed notes, graphs, photographs, drawings, oversize maps, and an oversize blueprint created by students of the UNM Chaco Canyon field schools between 1929 and 1938. The Notebooks also contain material related to Reiter's position as curator at the Museum of New Mexico, including records of loans, collections inventories, artifact lists and descriptions, catalog codes, and correspondence regarding acquisitions, as well as Paul Reiter's personal notes, research material, M.A. thesis, and notes related to the UNM Jemez field school.

The collection also contains Paul Reiter's personal collection of photographs, which includes negatives, prints, photocards, and interpositives of UNM field school excavations at Chaco Canyon between 1929 and 1941; aerial photographs of Chaco Canyon; and an album containing copies of historic photographs, newspaper and magazine clippings, and a hand-drawn map. The collection also includes a bound journal from Reiter's time at the Museum of New Mexico containing handwritten research notes, personal notes, object lists, addresses, drawings, and charts. The collection also includes publications on archaeology and ethnology collected by Reiter during his time as a professor at UNM.

The material in the Paul Reiter Collection came to the Chaco Archives at different times and under a variety of circumstances; the collection is therefore largely artificial. Most of the material was collected by the Chaco Project in the 1970s and 1980s. Because the Chaco Project kept few records about how material was acquired, much of the provenance information for the material in the Reiter Collection is vague or unknown. The bulk of the material was originally accessioned into the Vivian Archive; it was later transferred to the Reiter Collection when the Vivian Archive was dismantled and reorganized in 2011.

The Reiter Notebooks were assembled and bound by Paul Reiter. After Reiter's death in 1953, his wife Winifred Stamm Reiter became the custodian of his personal papers. In the late 1970s or early 1980s, Winifred Reiter donated the 6 Notebooks to the Chaco Project Archive. The loose photographs are copies of originals held at the Museum of New Mexico, which were collected and copied by the Chaco Project in the 1980s. The aerial photographs originally belonged to Paul Reiter; they were found in the UNM Department of Anthropology materials after these were acquired by the Chaco Project in the 1970s. The photograph album was donated to the Chaco Archives in December 1990 by Rebecca Lewis for the estate of Paul and Winifred Reiter. The journal was

## ***SERIES DESCRIPTIONS***

### *SERIES 1: REITER NOTEBOOKS, 1929-1938*

The Reiter Notebooks include Paul Reiter's collection of UNM field school and Museum of New Mexico materials. The Notebooks include material from all aspects of Paul Reiter's career between 1929 and 1938 and reflect his varied roles with UNM and the Museum of New Mexico.

The bulk of the material in the Notebooks was generated by the University of New Mexico field school, which operated in Chaco Canyon from 1929 to 1942 and again in 1947. The field school began as a joint operation between UNM and the School of American Research (SAR) and Museum of New Mexico (MNM) under the direction of Edgar L. Hewett, who served as director from 1929 to 1934. The collaboration between UNM and SAR/MNM lasted until 1935; after 1935, UNM operated the Chaco field schools independently. The Notebooks contain reports, notes, correspondence, and associated graphic materials describing excavations conducted at Chaco Canyon by the UNM field school between 1929 and 1938. This material primarily relates to the site of Chetro Ketl, but also includes reports and notes on other major sites in Chaco Canyon, such as Talus Unit 1 and Casa Rinconada; tree ring studies by Florence Hawley; and reports and notes from the UNM field school in Jemez, which ran concurrently with the Chaco Canyon field school. The Notebooks also contain records, inventories, notes, and correspondence related to Reiter's position as Curator of Archaeology at the Museum of New Mexico, which he held from 1931 to 1938, as well as Reiter's personal notes and research, including drafts of his 1933 M.A. thesis on Chetro Ketl.

The Notebooks provide a record of the activities of the UNM field school in Chaco Canyon and the Museum of New Mexico while also reflecting Reiter's personal interests. Most of the material was collected by Reiter during his association with the field school, first as a student from 1929 to 1932 and then as a faculty member in 1933, 1940-1941, and 1947. Reiter made multiple copies of student reports for his personal research use and kept both Museum of New Mexico materials and his own notes and research intermixed with them; he later bound all of this material into 6 volumes. For the most part, the Notebooks lack a strong sense of internal organization. In some cases, multiple copies of the same report were bound in separate volumes or a single report or set of notes was split up and bound in separate volumes. This organization has been retained to preserve Paul Reiter's original order. *SUBSERIES A: PROFESSIONAL PAPERS AND CORRESPONDENCE, 1932-1939 (bulk dates: 1938-1939)*

Chronological

Includes some pieces of Reiter's professional writing, Field school inventories and lists, correspondence mainly regarding UNM, Field School and WPA project.

*SUBSERIES B: WPA MATERIAL AND CORRESPONDENCE, 1936-1939 (bulk dates: 1938-1939)*

Paul Reiter was Foreman for and ran a WPA project at Chaco from approximately 1937-1939, during which time the WPA contract was shifted from SAR to UNM (February 1, 1938), when UNM and SAR terminated shared staffing arrangements.

Consists of WPA reports, management memos, forms, correspondence to and from Reiter regarding WPA work.

*SERIES 3: PHOTOGRAPHS, circa 1868-1941 (bulk dates: 1910-1941)*

Photographs taken and collected by Paul Reiter during his time with the UNM field schools and the Museum of New Mexico. Includes images of UNM field school excavations in Chaco Canyon between 1929 and 1941. Most of the images show excavations at Chetro Ketl, but also include Talus Unit 1, BC 50, 51, 52, and 53, Threatening Rock, and Pueblo Bonito. The majority of these images are copies of photographs held at the Museum of New Mexico which were acquired by the Chaco Project in the 1980s. The Chaco Project placed the photographs on photocards and, in some instances, made copy prints and negatives. Many of these photographs are attributed to Paul Reiter or John Russell; however, some of the photographs may have been taken by other UNM field school students.

Also includes a set of aerial photographs of Chaco Canyon which belonged to Paul Reiter while he was a professor in the UNM Department of Anthropology. These aerial photographs were most likely taken between 1927 and 1935, possibly by Carlos Vierra.

\_\_ Paul Reiter's album of personal and historic photographs. The album primarily contains copies of historic photographs from the late nineteenth and early twentieth centuries by notable photographers such as Adolph Fisher, Christian Kaadt, Charles F. Lummis, Jesse L. Nusbaum, Wesley Bradfield, and Adam Clark Vroman. Photographs taken and collected by Paul Reiter during his time with the UNM field school. Includes images showing excavations at Chaco Canyon undertaken by the field school between 1929 and 1941. Most of the images show excavations at Chetro Ketl, but also include Talus Unit 1, BC 50, 51, 52, and 53, Threatening Rock, and Pueblo Bonito. Most of the photographs are attributed to Paul Reiter or John Russell, and Anna O. Shepard; some photographs may have been taken by other field school students. Contains negatives, prints, photocards, and interpositives; the majority of these are copies of originals held by the Museum of New Mexico and acquired by the Chaco Project in the 1980s. Transferred from Chaco Center Historic Photograph Collection in 2011 (series previously known as 28/5.11).

**SERIES 3: BOX 2 02. Aerial Photographs, between 1927 and 1935**

Aerial photographs of Chaco Canyon, including sites of Chetro Kettle and Pueblo Bonito. Originally belonged to Paul Reiter and found in UNM Department of Anthropology materials. Each image has 2 prints, one a reverse image of the other. According to Carla Van West, photographs may have been taken before 1929 because of the lack of certain structures such as hogans and the superintendent's building. According to Dr. Joan Mathien, photographs were possibly taken by Carlos Vierra. Transferred from Vivian Archive in 2011.

1 bound volume containing handwritten research notes, personal notes, object lists, addresses, diagrams, drawings, charts, and tables, mostly related to his position at the Museum of New Mexico. Loose papers tucked in between pages of journal are now held in file folders labeled with the section of the journal in which they were originally found.

**SERIES 4: BOX 2 – 02. Photograph Album, circa 1868-circa 1940****SERIES 4: BOX 4**

Photograph album containing Paul Reiter's collection of personal and historic photographs. Album disassembled for preservation, all items removed from pages and placed in folders in negative number order. Inscriptions are on small slips of paper in separate folders accompanying each item, arranged by negative number. Larger images and inscriptions are in SERIES 4 BOX 5, in negative number order. First page of Album is in OS BOX 1, FOLDER 3.

Contains images of archaeological sites in New Mexico, including Chaco Canyon, Quarai Ruins, Kuaua Ruins, and possibly Jemez. Also contains copies of historic photographs from the late nineteenth and early twentieth centuries by notable photographers such as Adolph Fisher, Christian Kaadt, Charles F. Lummis, Jesse L. Nusbaum, Wesley Bradfield, and Adam Clark Vroman. These include images of New Mexico churches and pueblos; Bandelier National Monument; Santa Fe plaza; rooms and artifacts at the Palace of the Governors/Museum of New Mexico; and Jesse Nusbaum's photographs of School of American Research archaeological expeditions in Quirigua, Guatemala and Copan, Honduras in the 1910s. Also includes newspaper and magazine clippings and hand-drawn map of BC 51. Most of the historic photographs in the album are not original, but were copy prints collected by Paul Reiter, probably during his time as curator at the Museum of New Mexico from 1931 to 1938. Many of the original photographs for images in this album are currently housed at the Palace of the Governors Photo Archives in Santa Fe. Dates of photographs in the album are based on when the original image was captured rather than when the print was created and collected by Reiter.

**SERIES 4: BOX 5 03. Research Materials, 1937-1942**

Contains two publications collected by Paul Reiter while he was a professor in the Department of Anthropology at UNM. Publications are related to Paul Reiter's personal and professional interests in archaeology and ethnology, they include a report describing Native American ethnographic objects at the Denver Art Museum and the Notebook of the Society for American Archaeology.
