Summary Overview

2024 - A Remarkable Year:

1. Recreation.gov: It is hard to believe how quickly time flies – our backcountry permit system has now been on Recreation.gov one full year! The good news is that the new system continues to improve, especially as we all become more familiar with its capabilities. We are pleased to see that the public can easily check availability, reserve, pay for, and print most permits directly, all without the need to wait for Ranger assistance. Looking ahead, we anticipate an even brighter future as programmers address more of our requests and implement additional improvements.

2. Trans-Canyon-Waterline (TCWL): The park's initiative to replace the Trans-Canyon Waterline is well underway, and an impressive amount of work has already been accomplished. In 2024, the temporary impacts on backcountry use included extended shutdowns of the Bright Angel Trail, Havasupai Gardens Campground, Bright Angel Campground, and the Plateau Point Spur Trail. While these closures were necessary for public safety, the good news is that the shutdowns for these areas are mostly coming to an end. By mid-May 2025, we expect most of these areas to be fully reopened. Thank you all for your continued patience and continued understanding!

3. Retirement of BIC Manager: It has been an honor to serve you and our country since 1993 through Grand Canyon National Park and the Backcountry Information Center. Please accept my heartfelt gratitude to all of you for your incredible love and care for the canyon, your unwavering support of the National Park Service, and the time you have dedicated to advocating for the greater good. It has been a pleasure to represent all of you, and as I sail on to new adventures, I wish you the best!

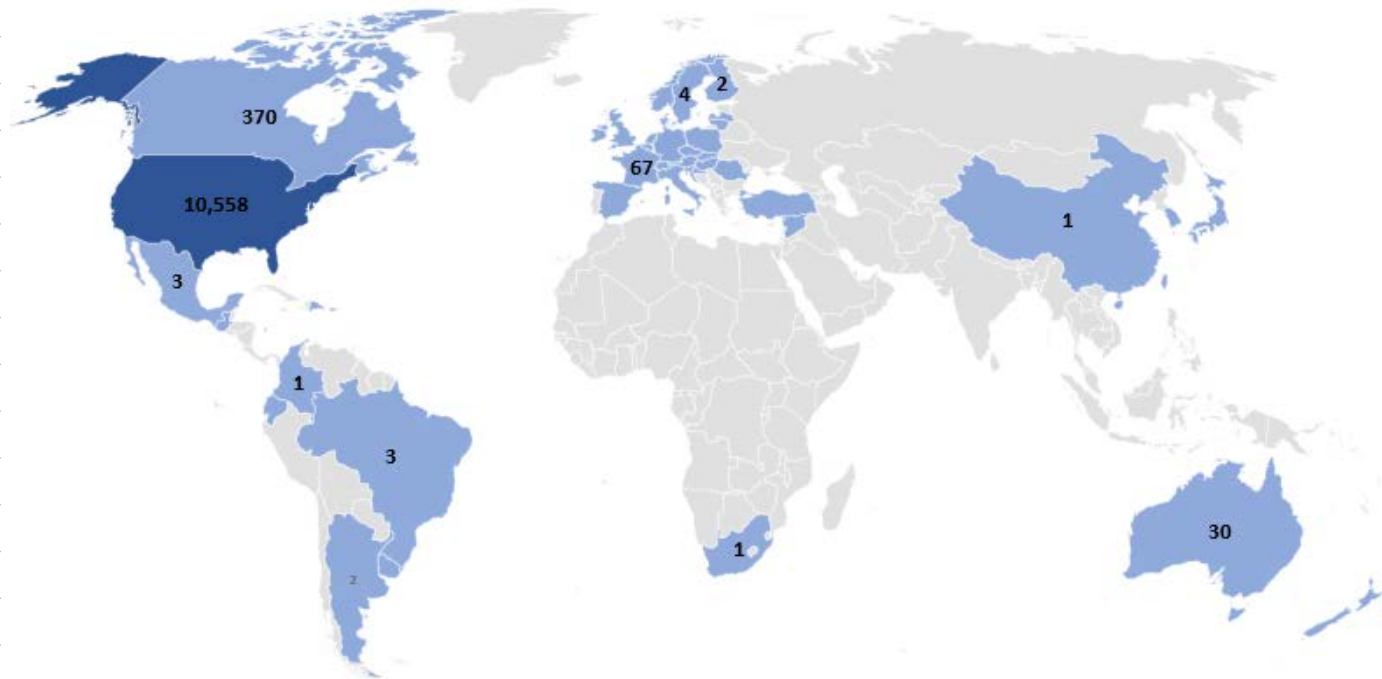

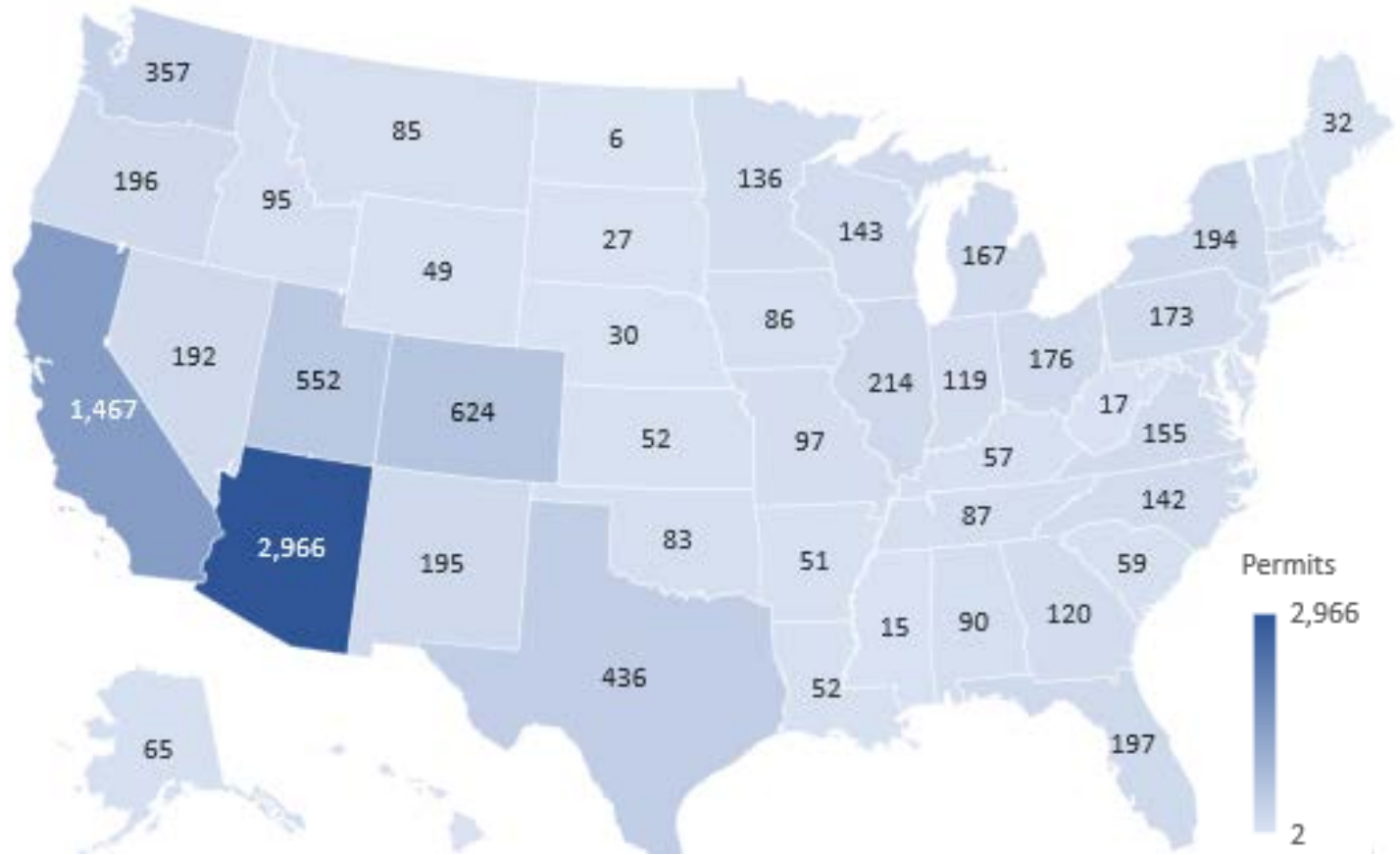

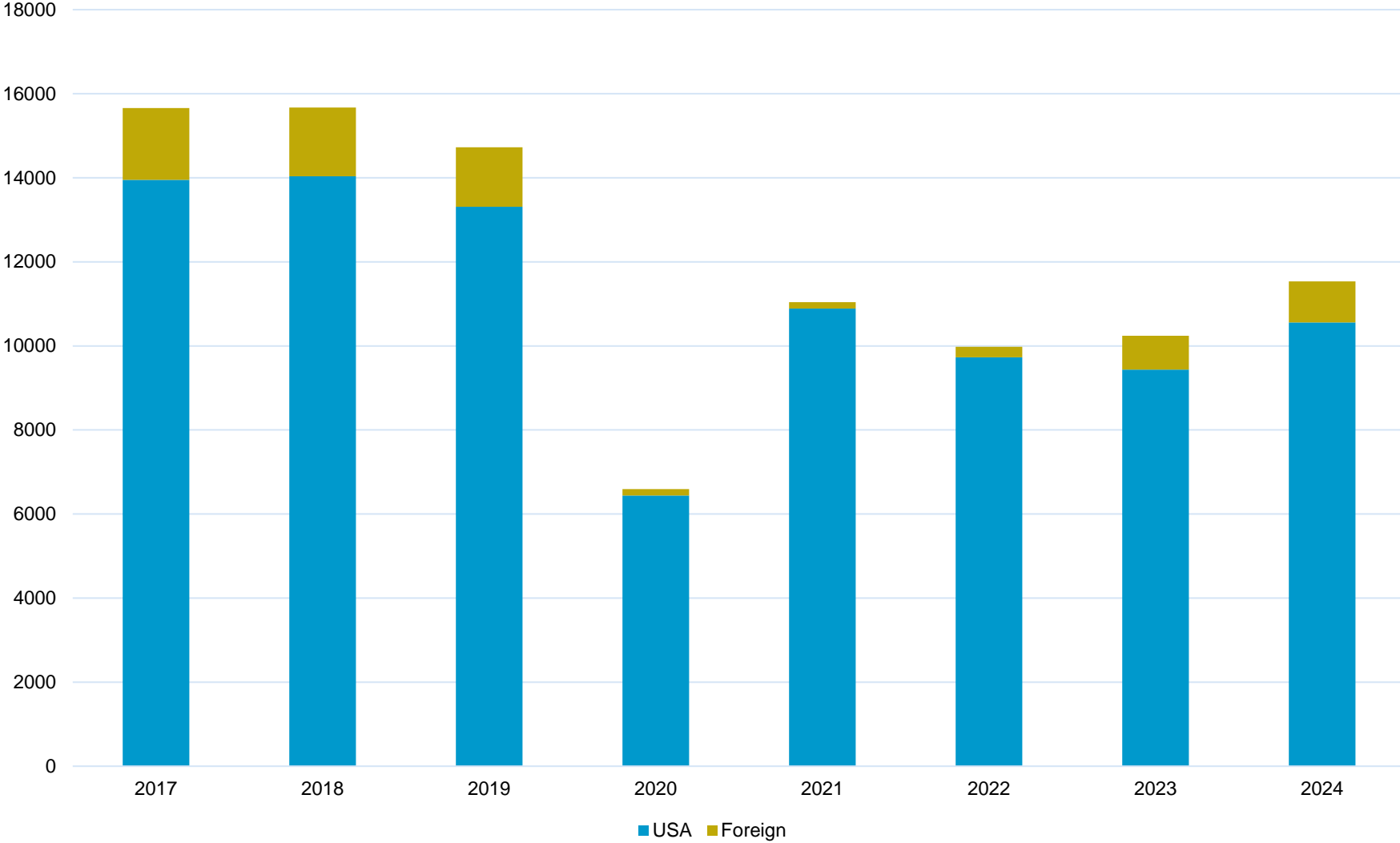

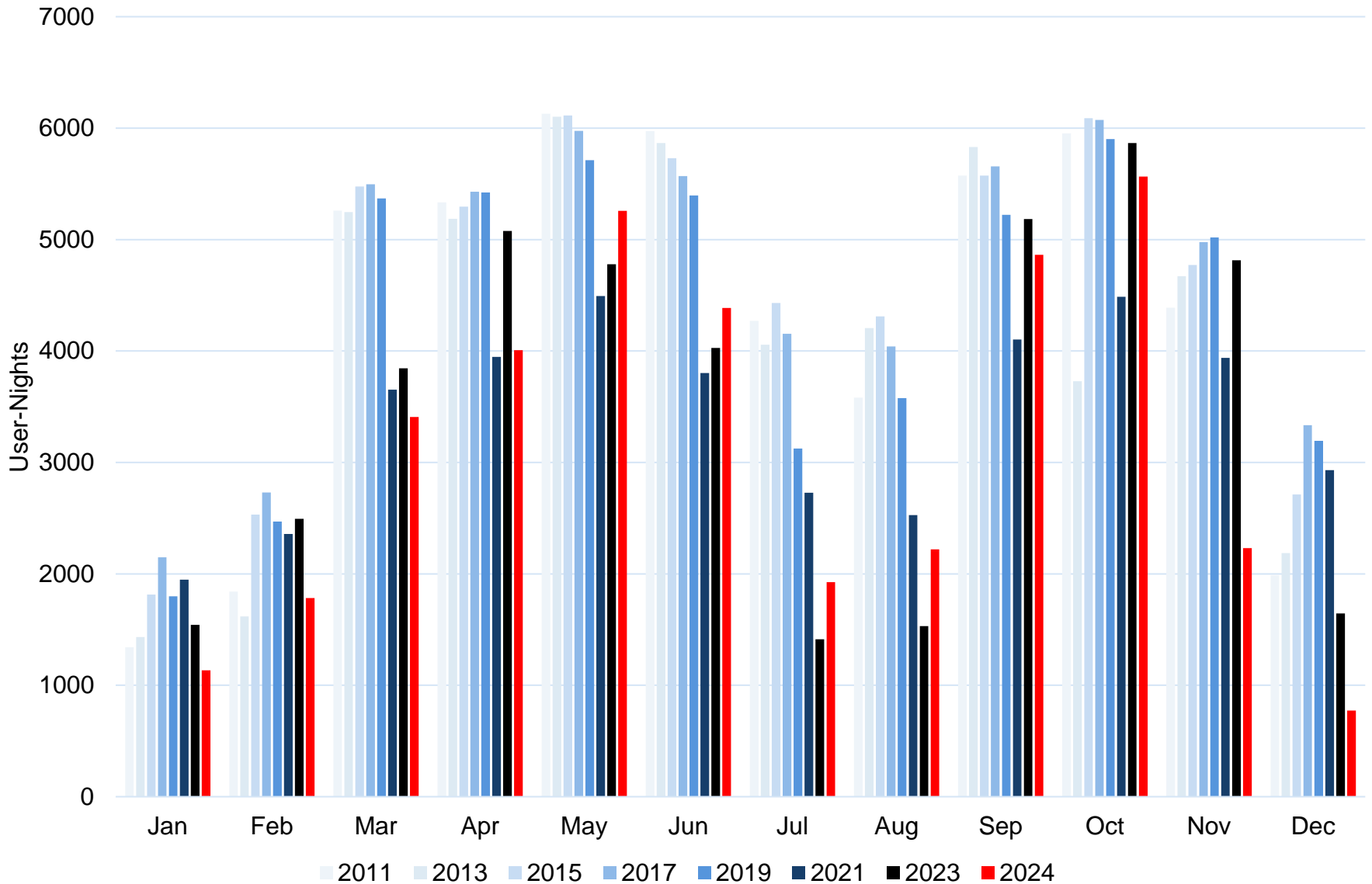

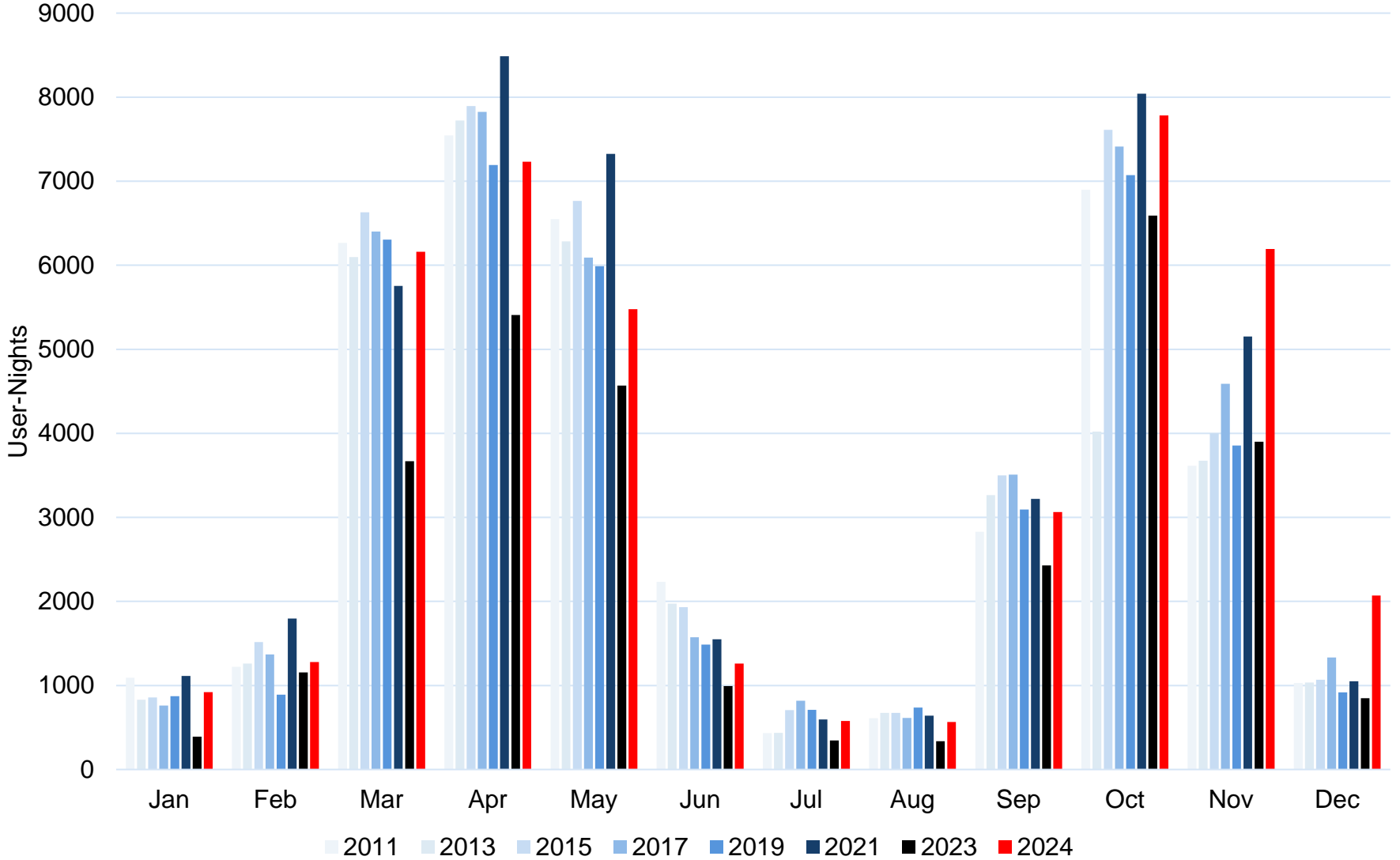

Non-Corridor User-Nights

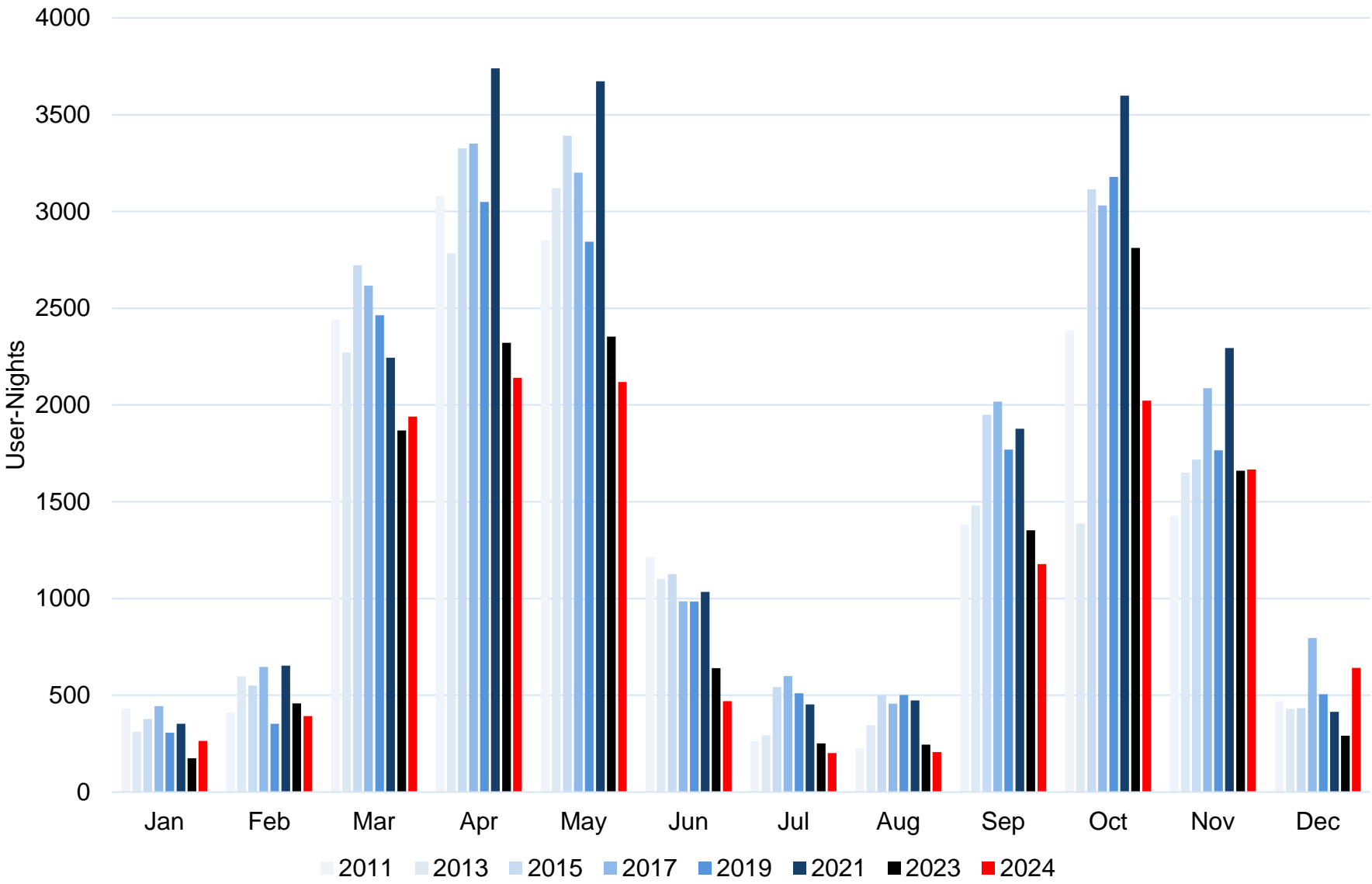

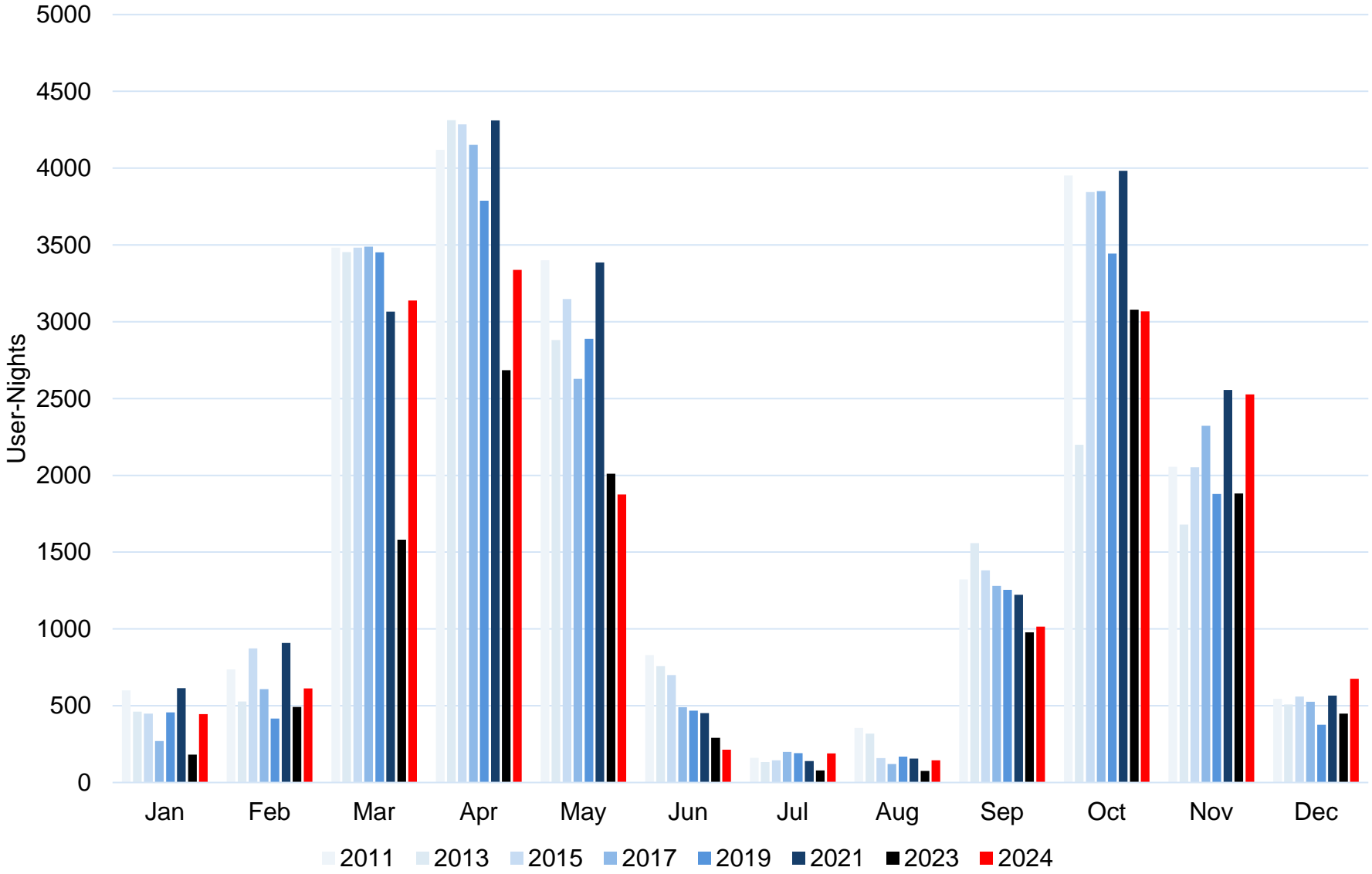

Threshold Use Areas User-Nights



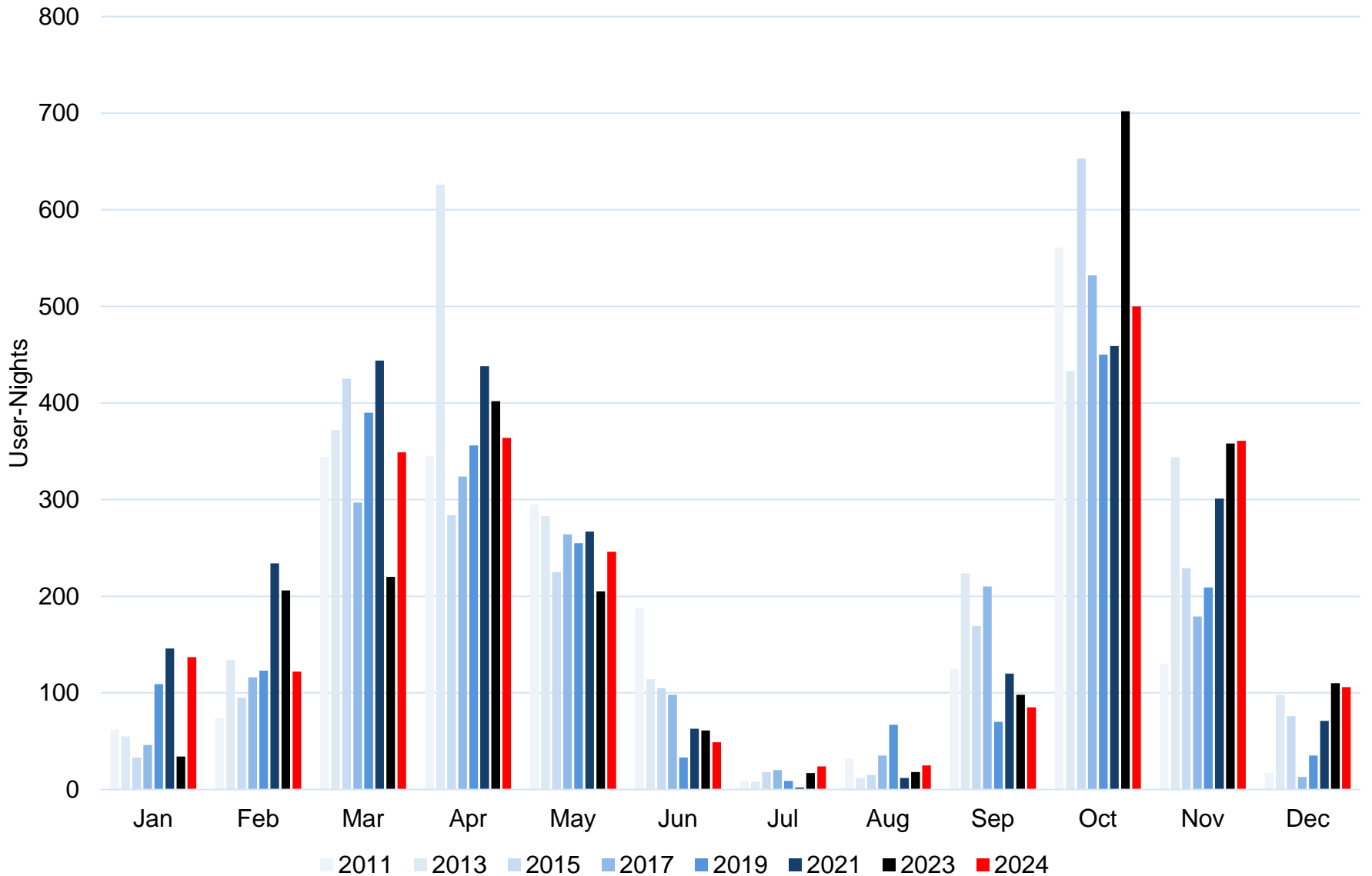

Primitive Use Areas User-Nights



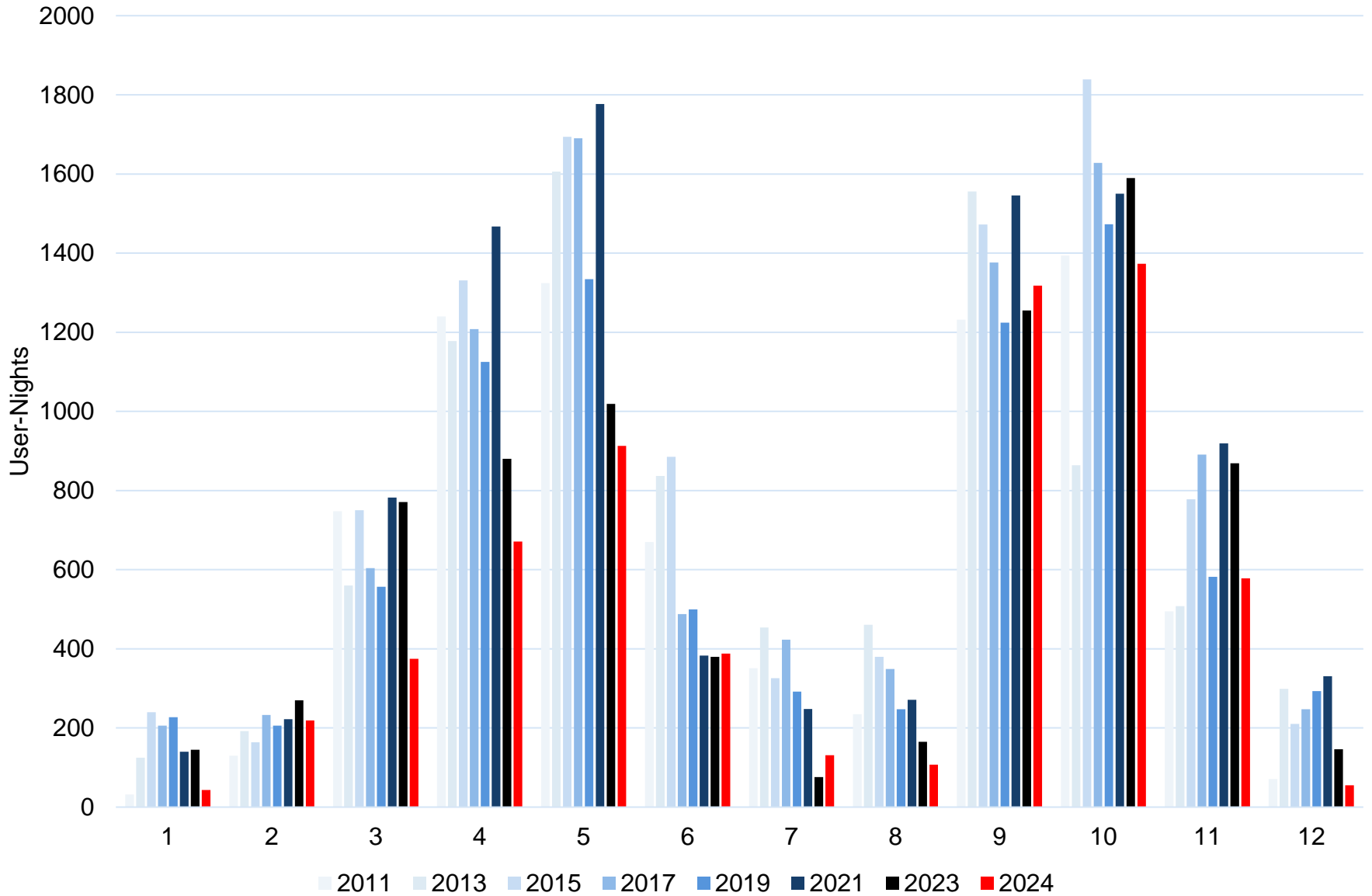

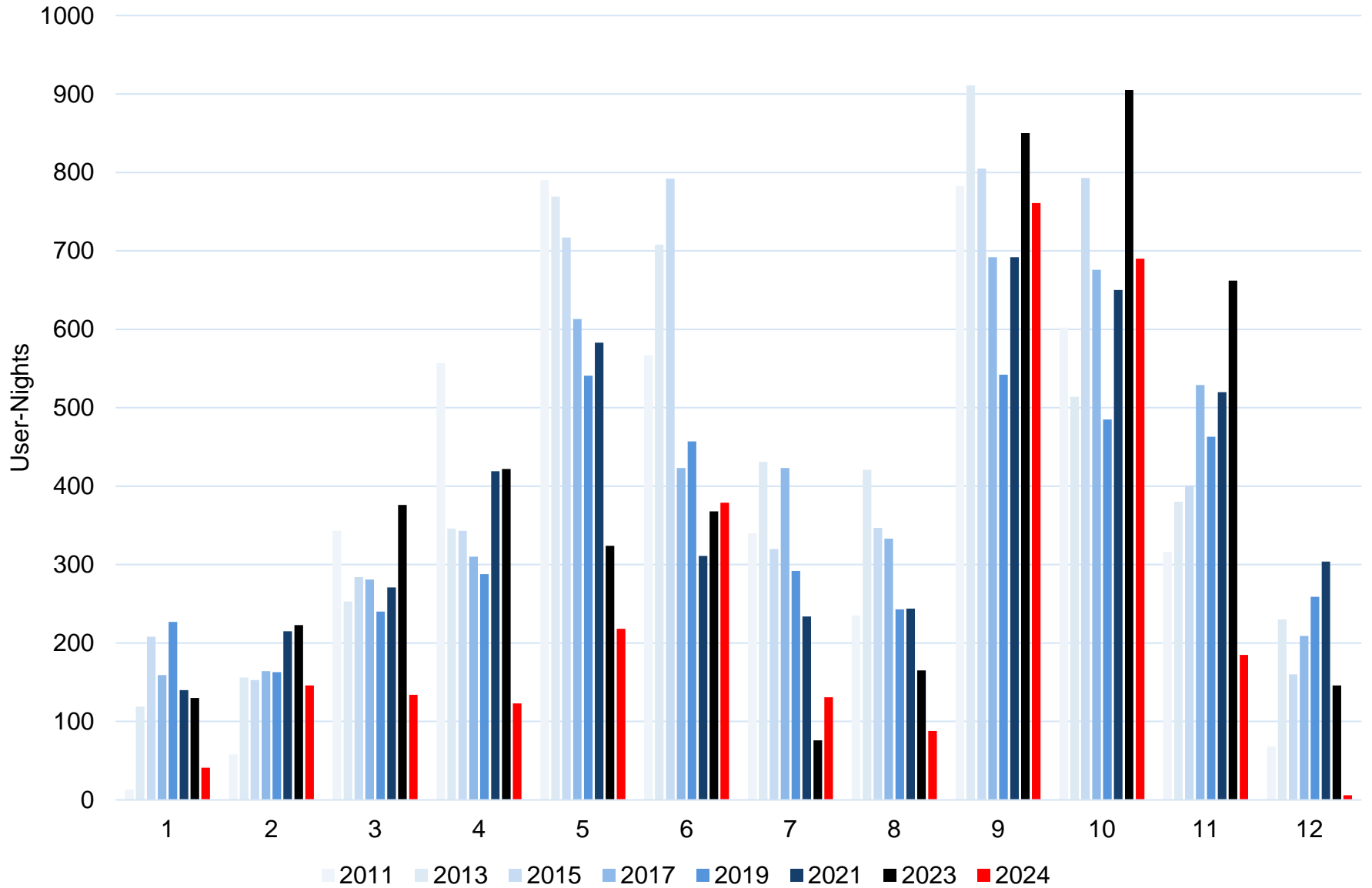

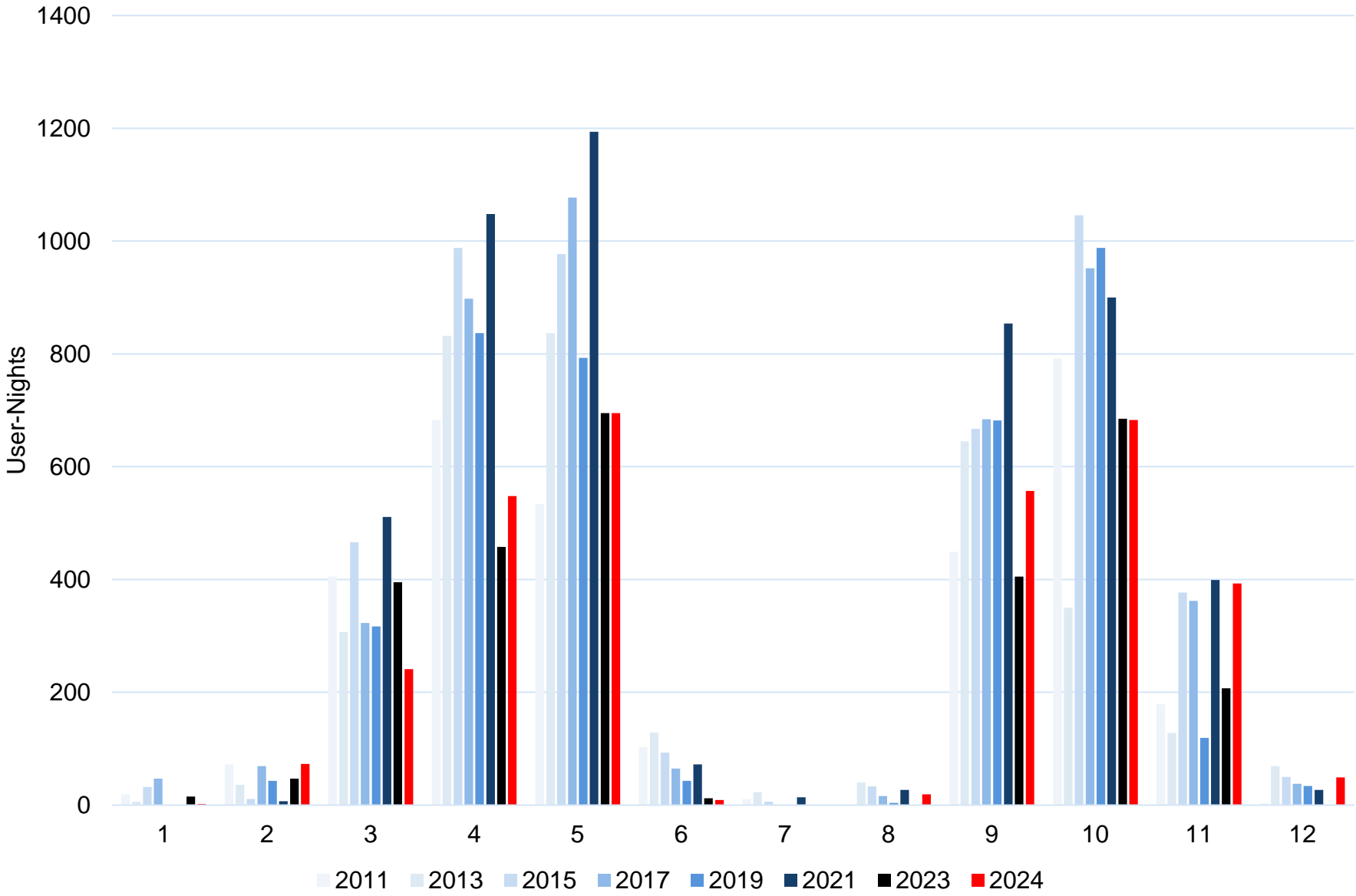


Backcountry Commercial Use in Corridor, 2011-2024

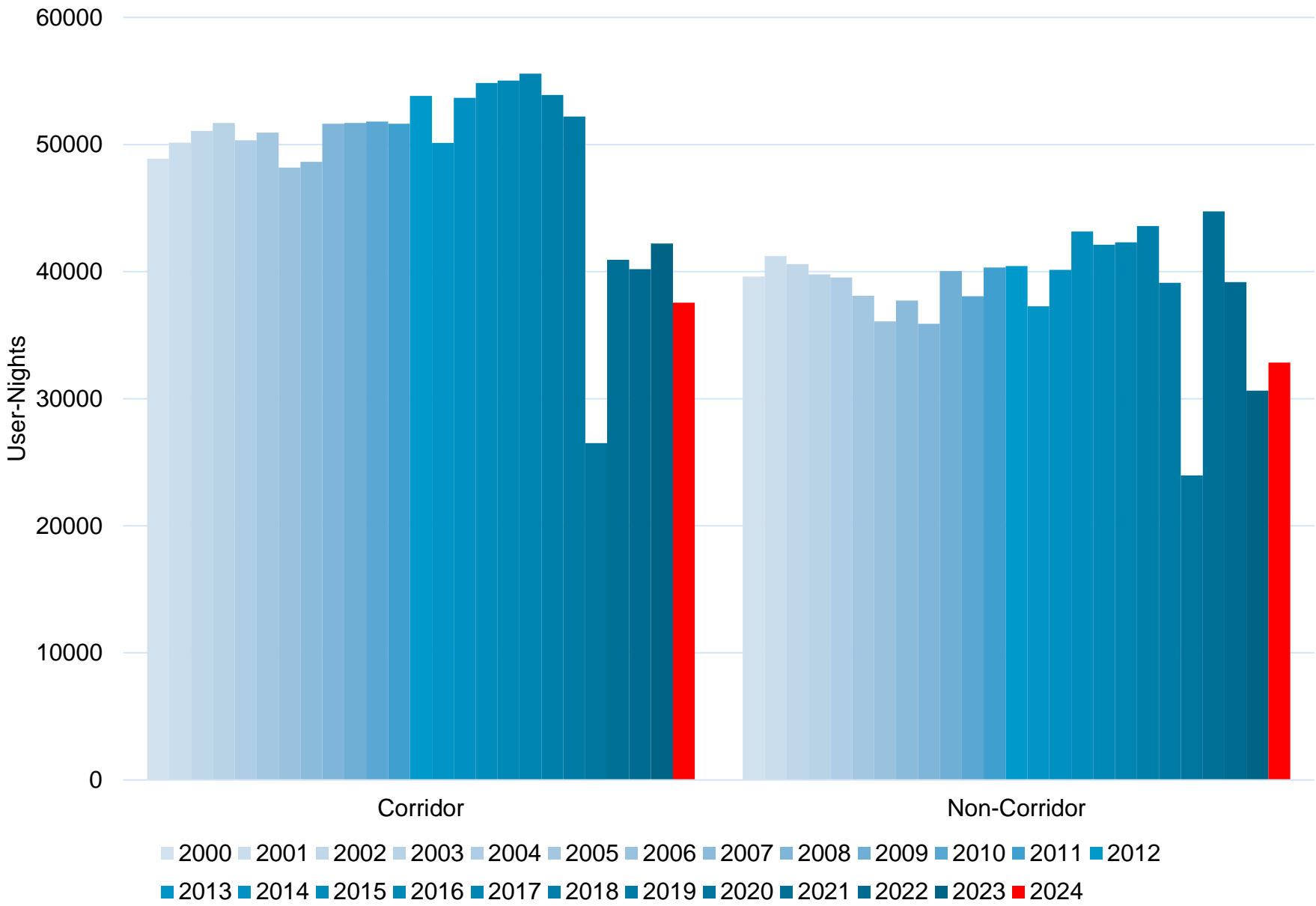

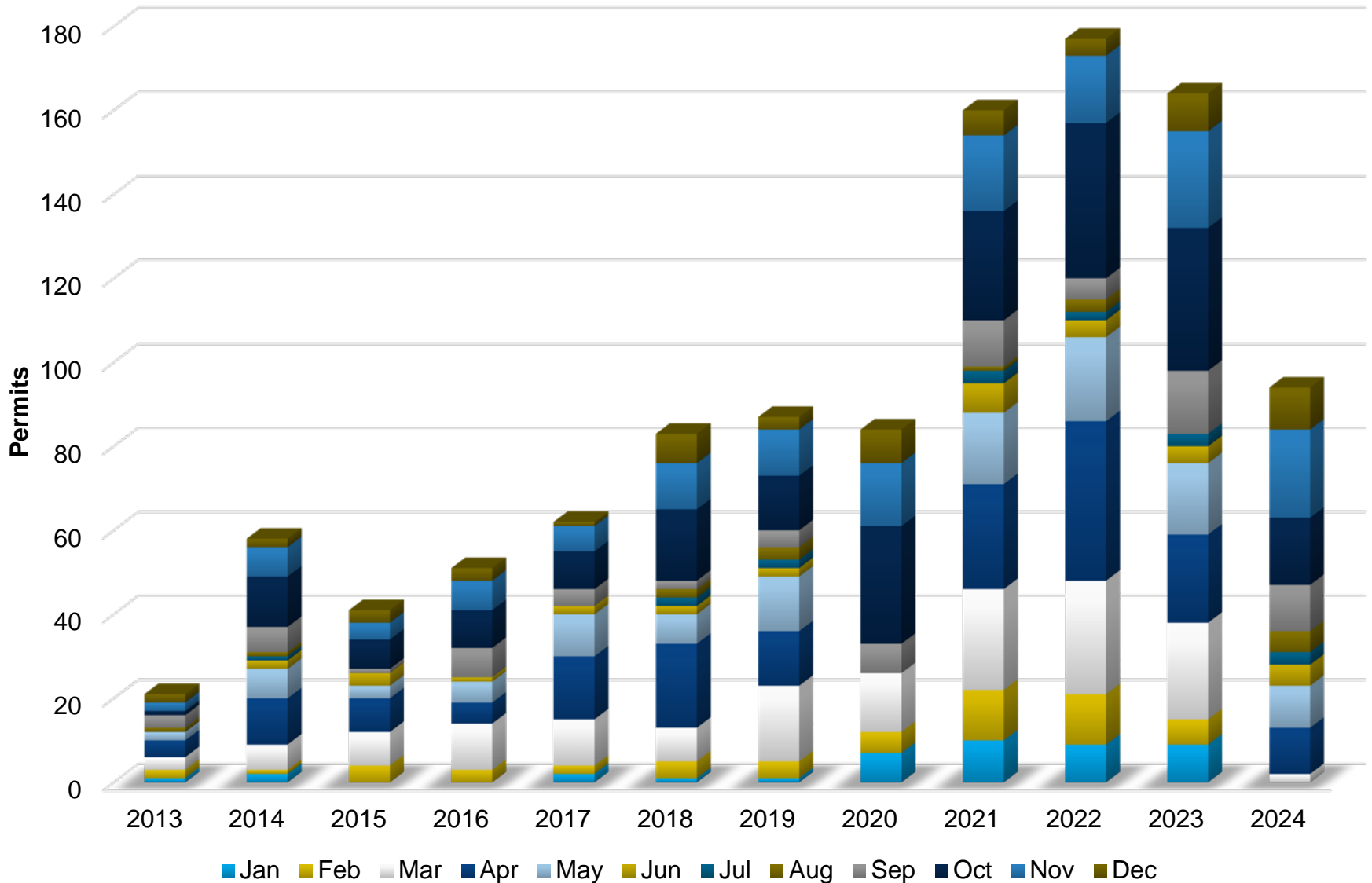
Backcountry Commercial Use in Non-Corridor, 2011-2024 User-Nights



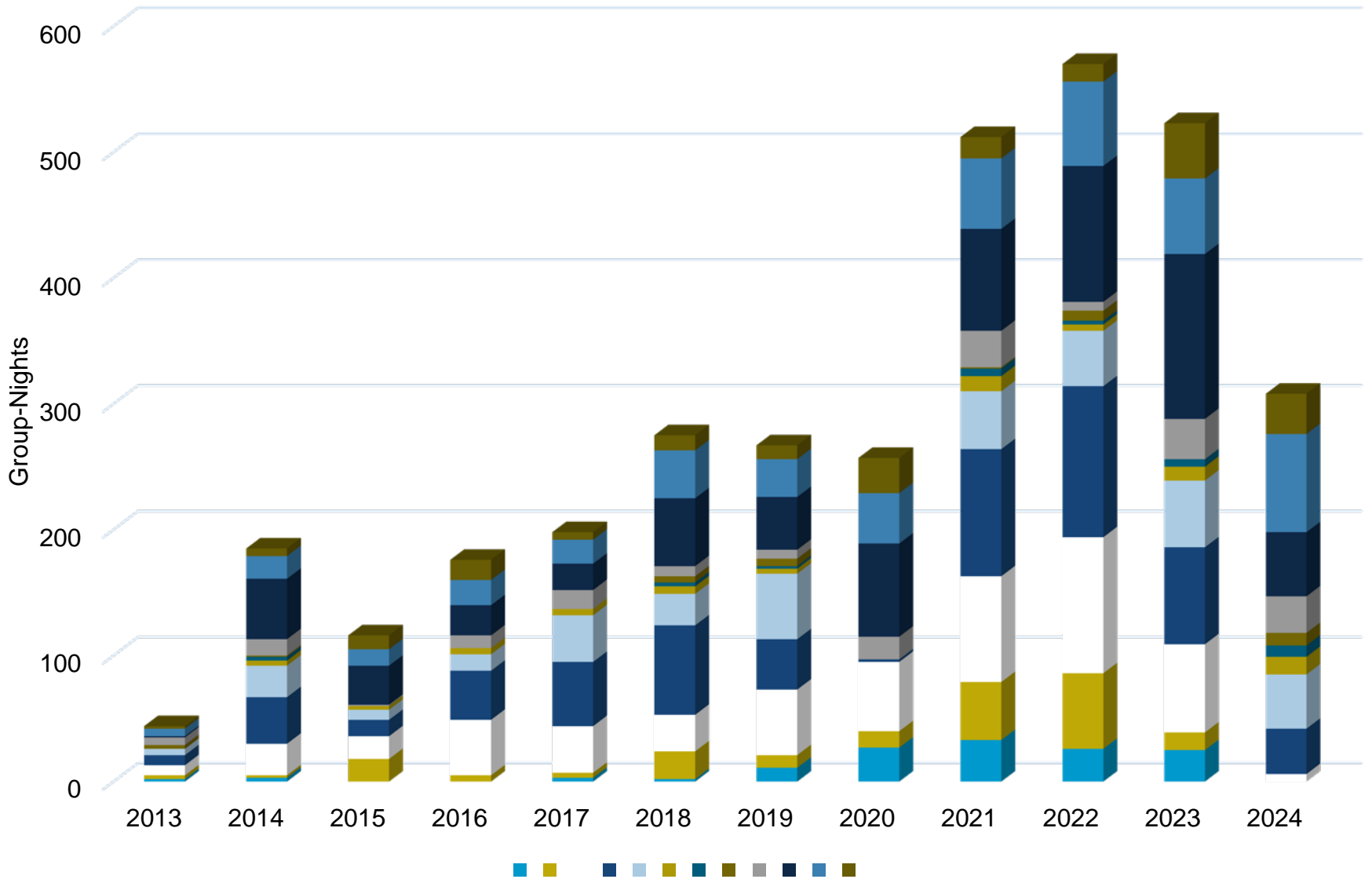
Backcountry User-Nights in 2024: Corridor and Non-Corridor



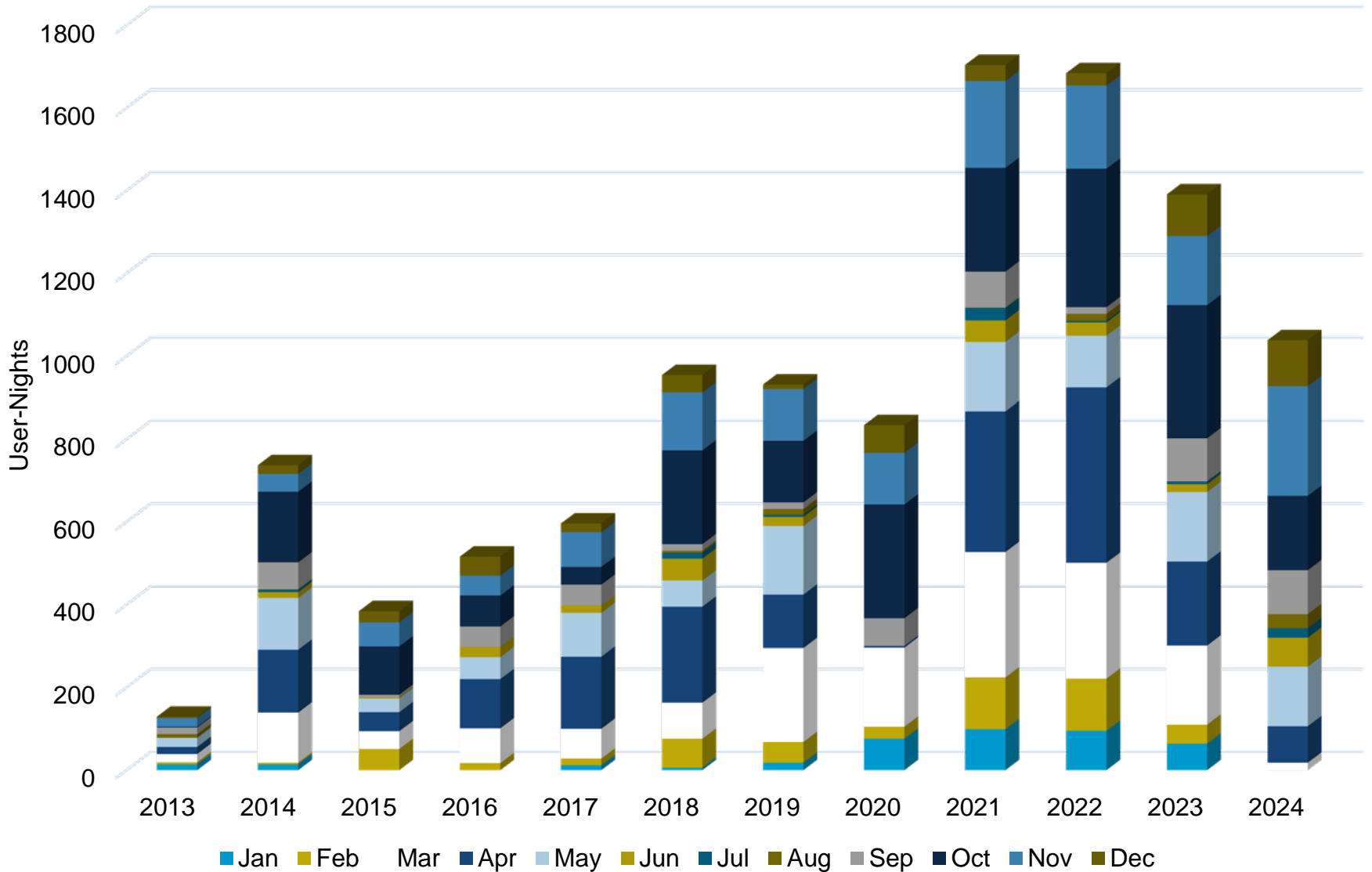

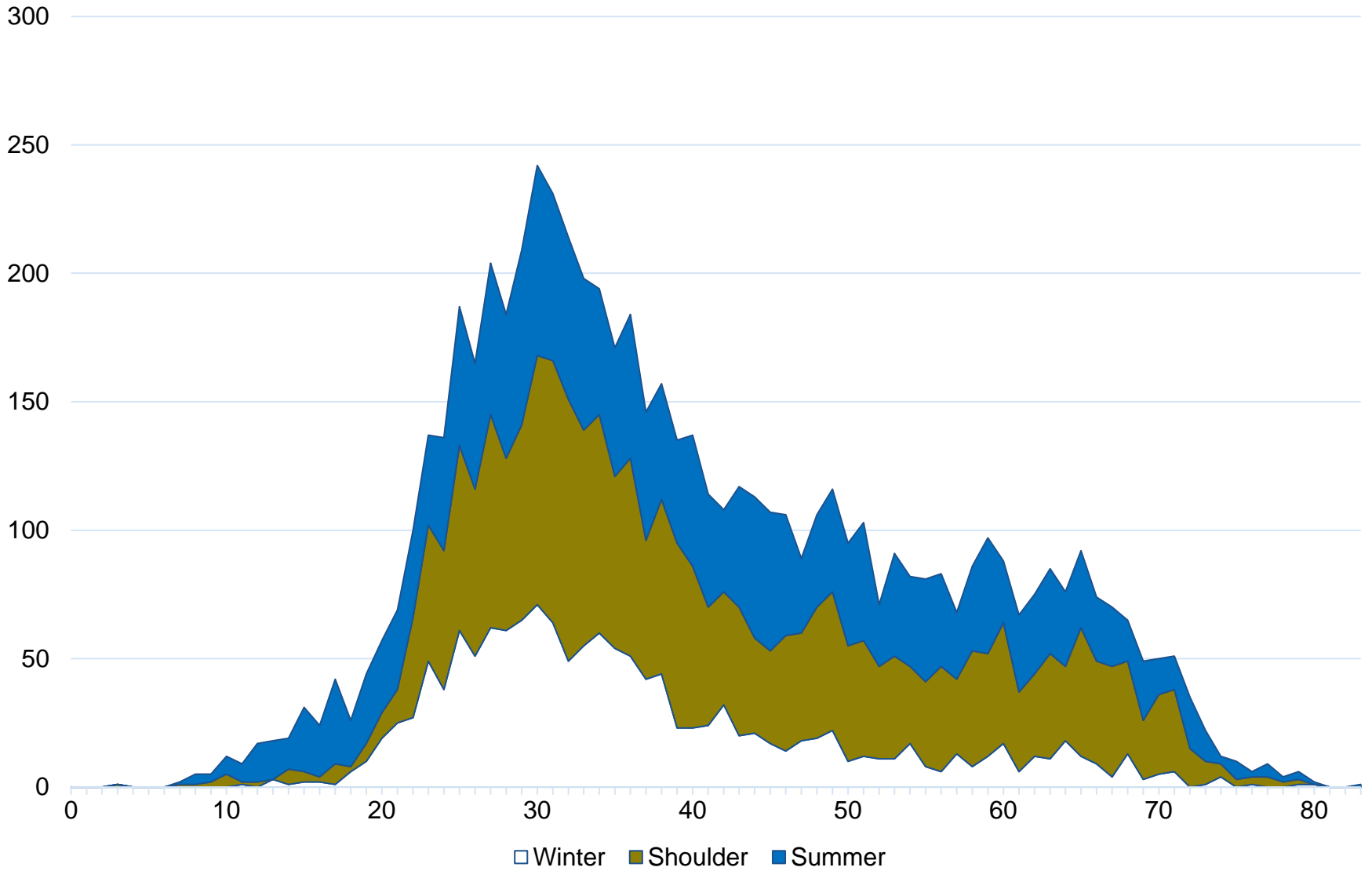

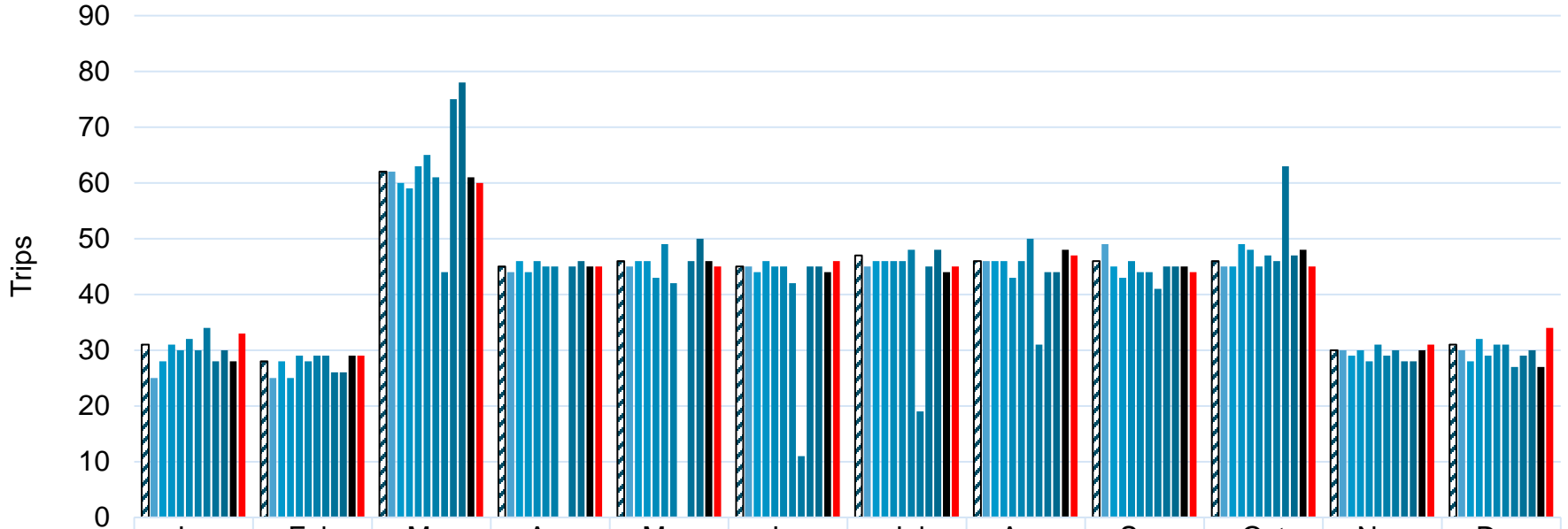

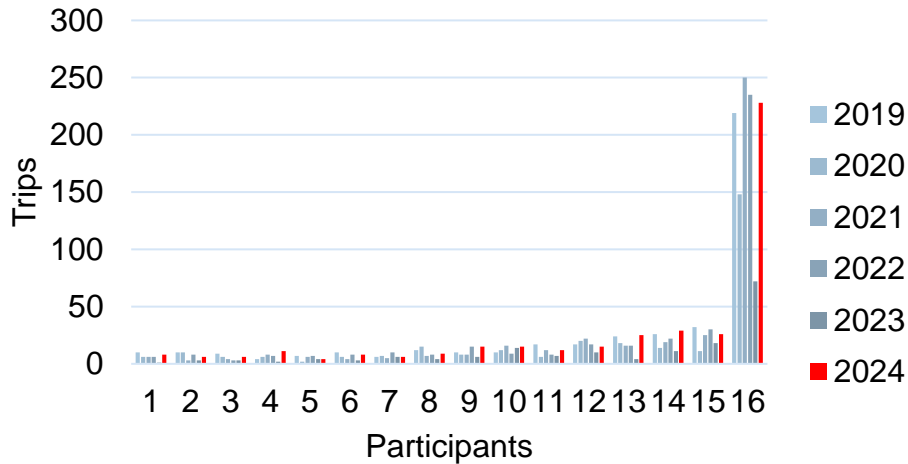
Small Sized Trips (1-8 p)



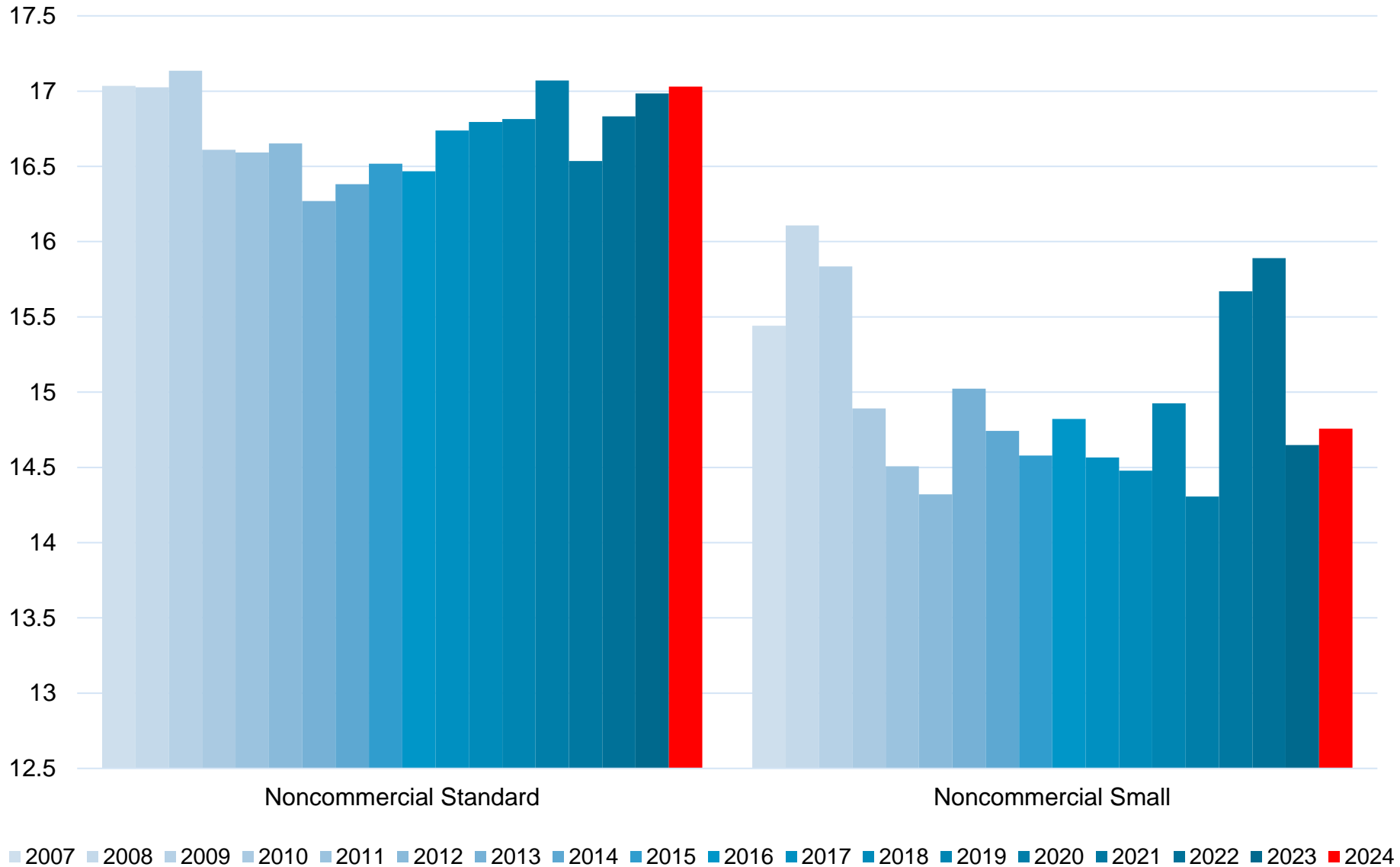
Average Trip Size

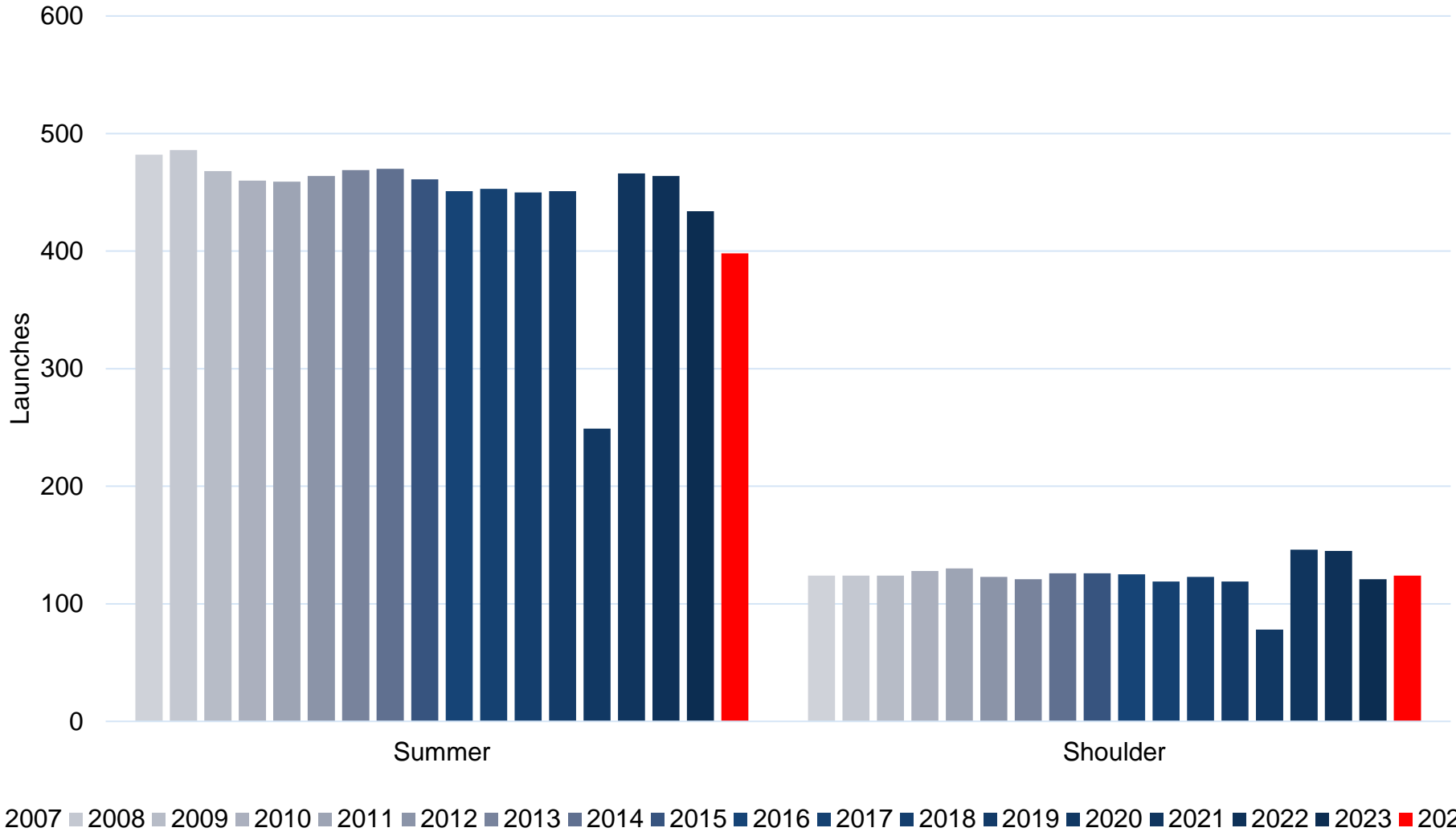

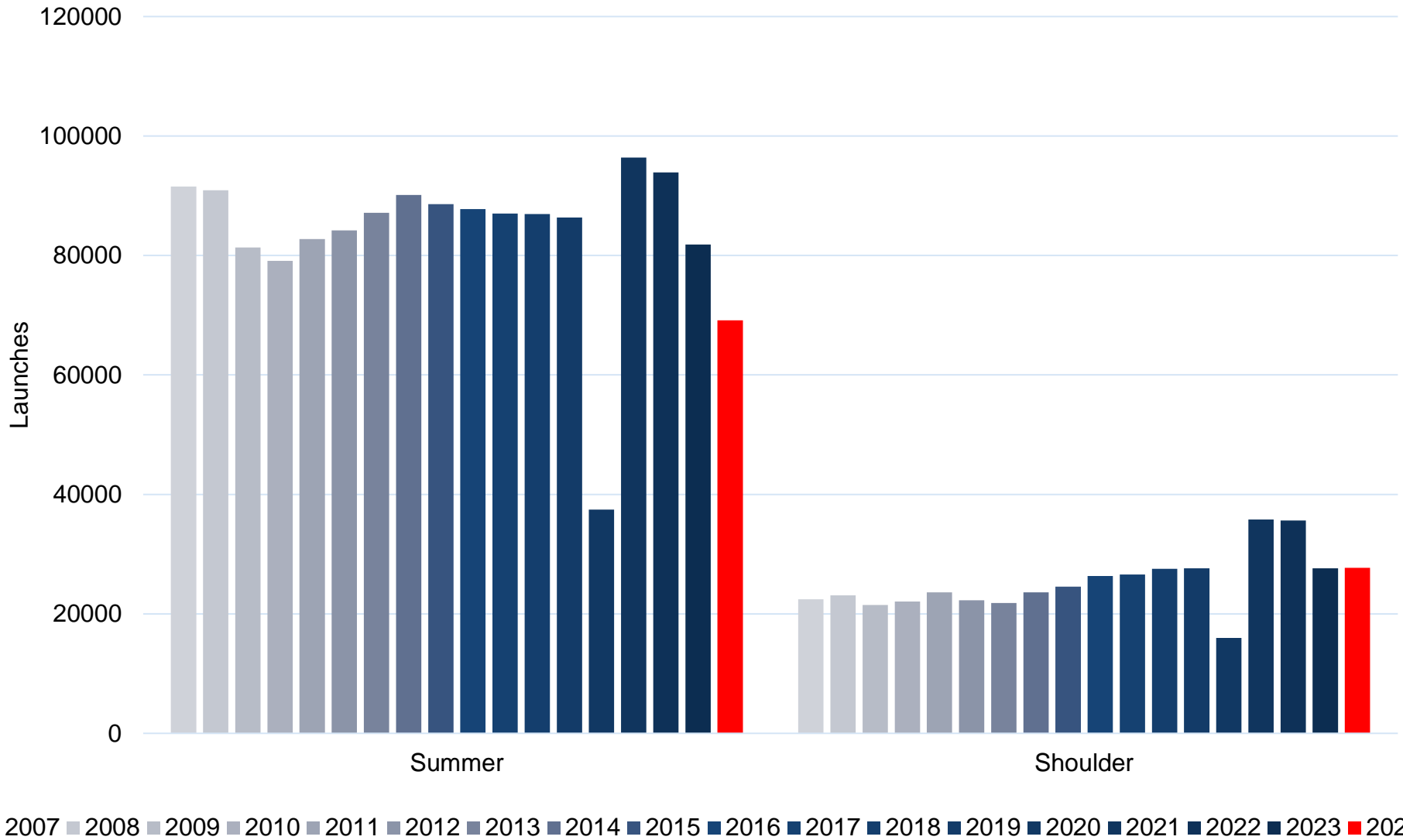

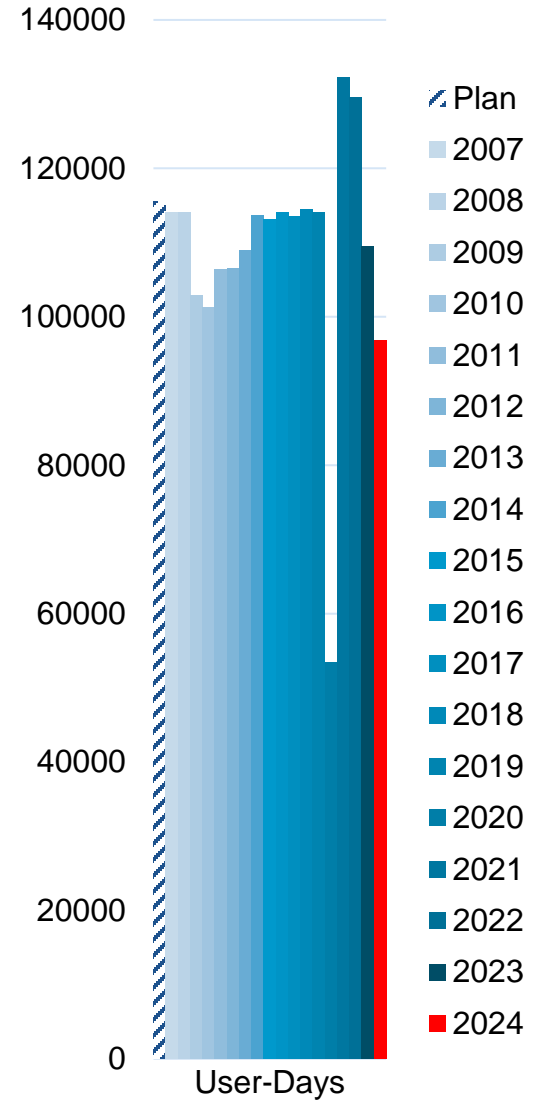
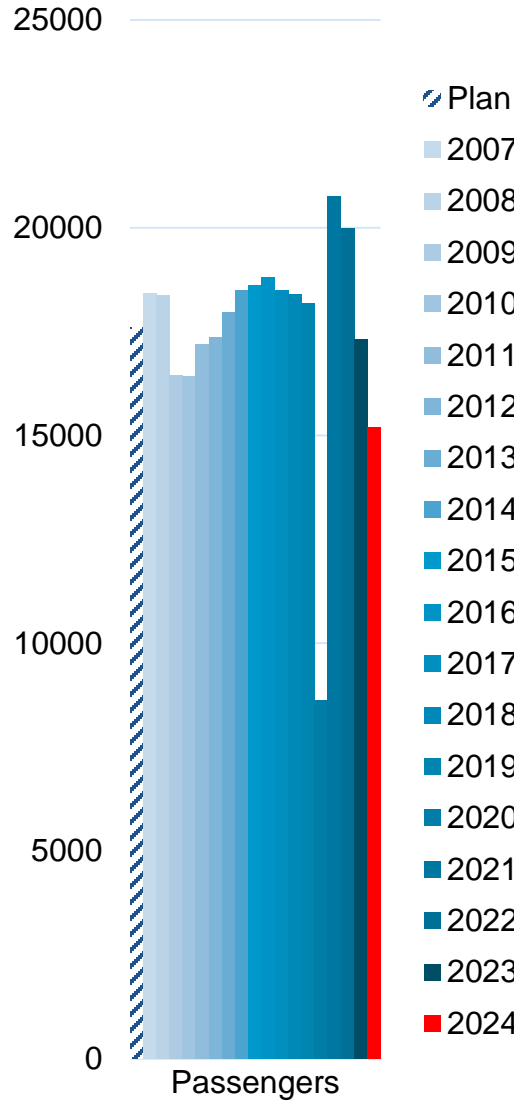
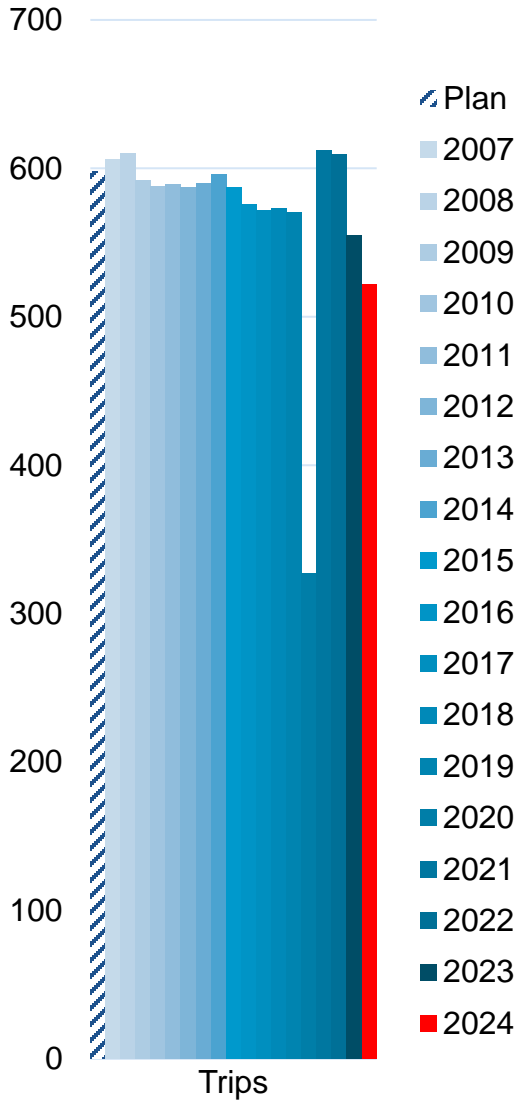
River – Lees Ferry to Diamond Creek Commercial Passenger Counts by Season

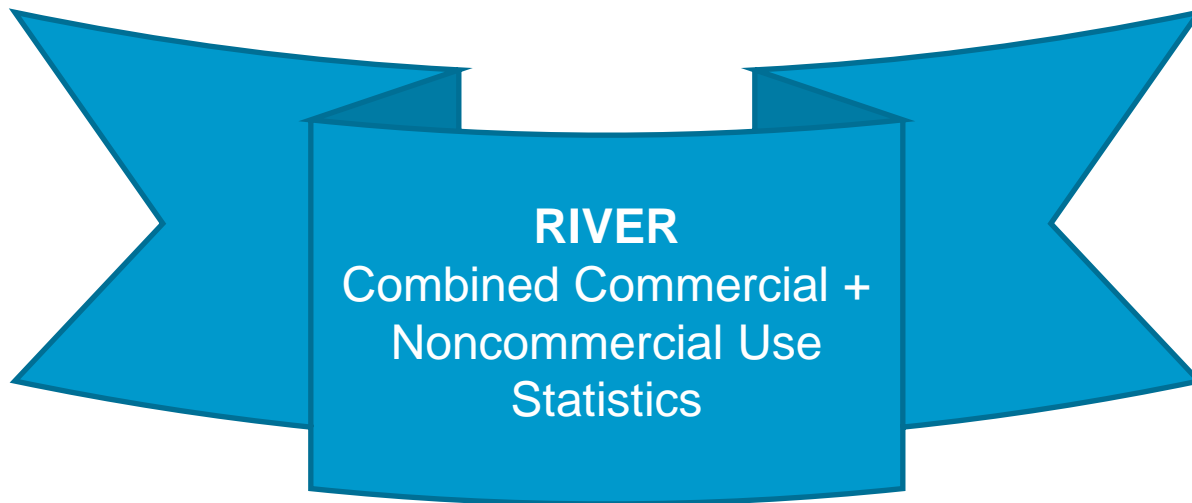

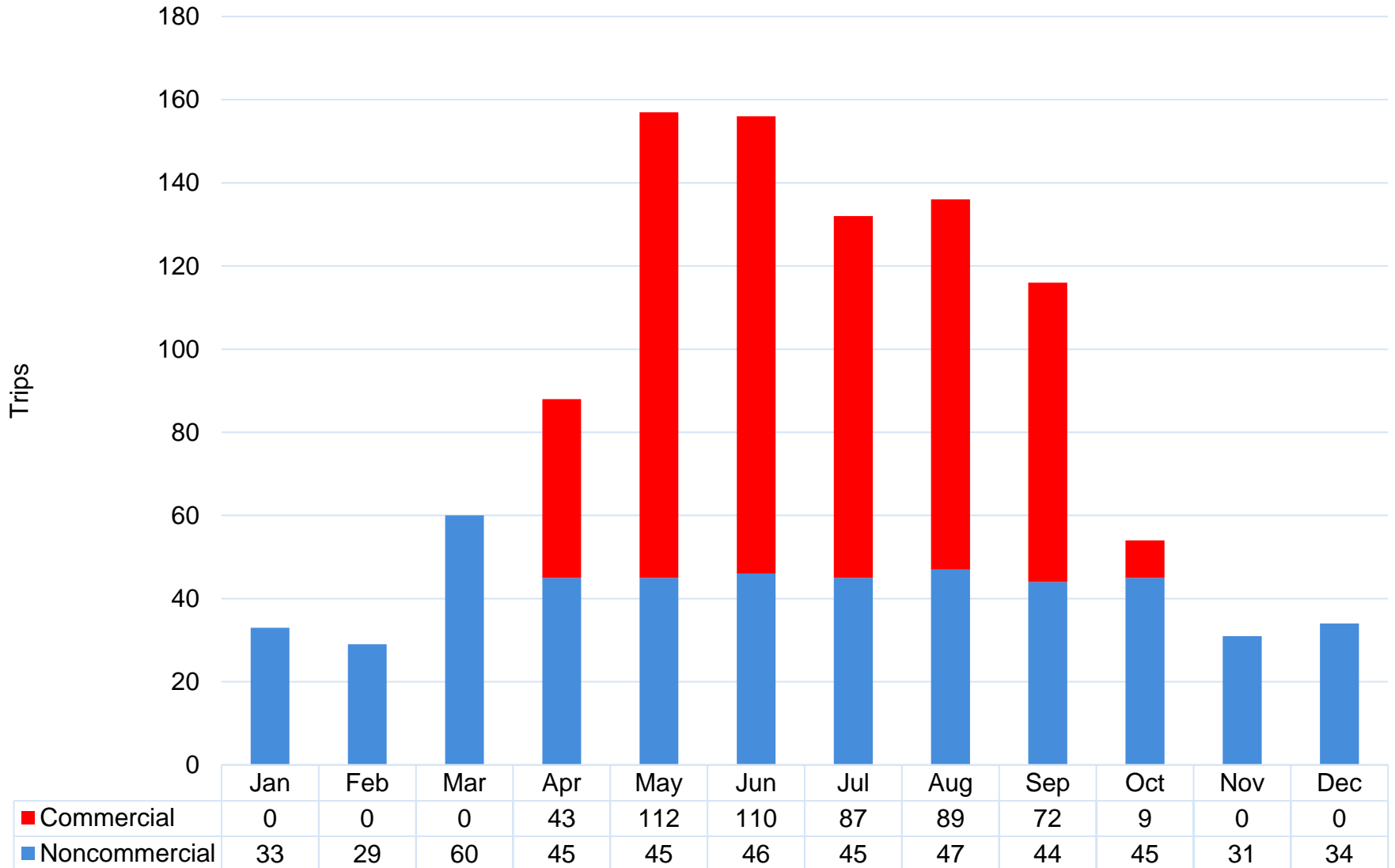

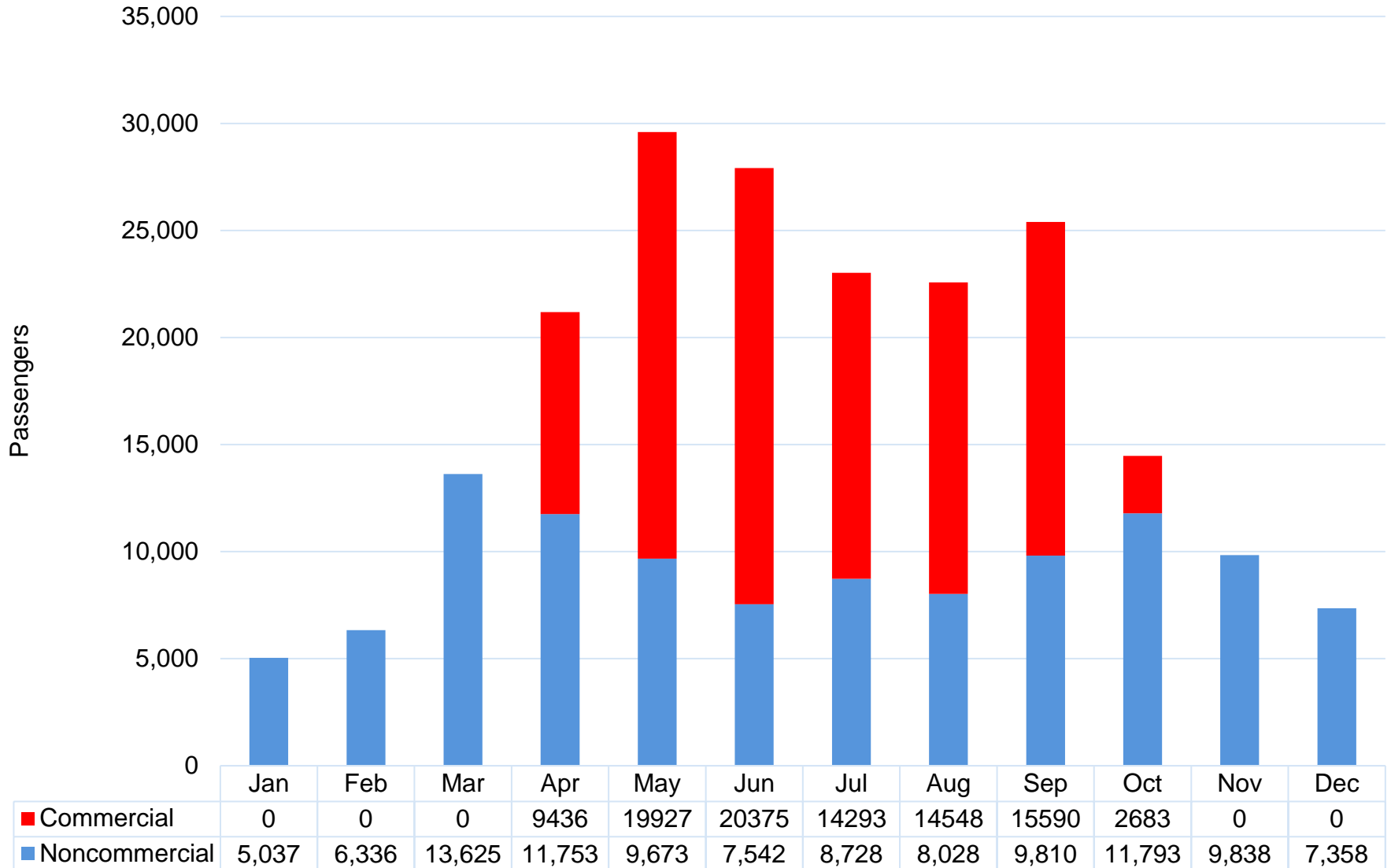

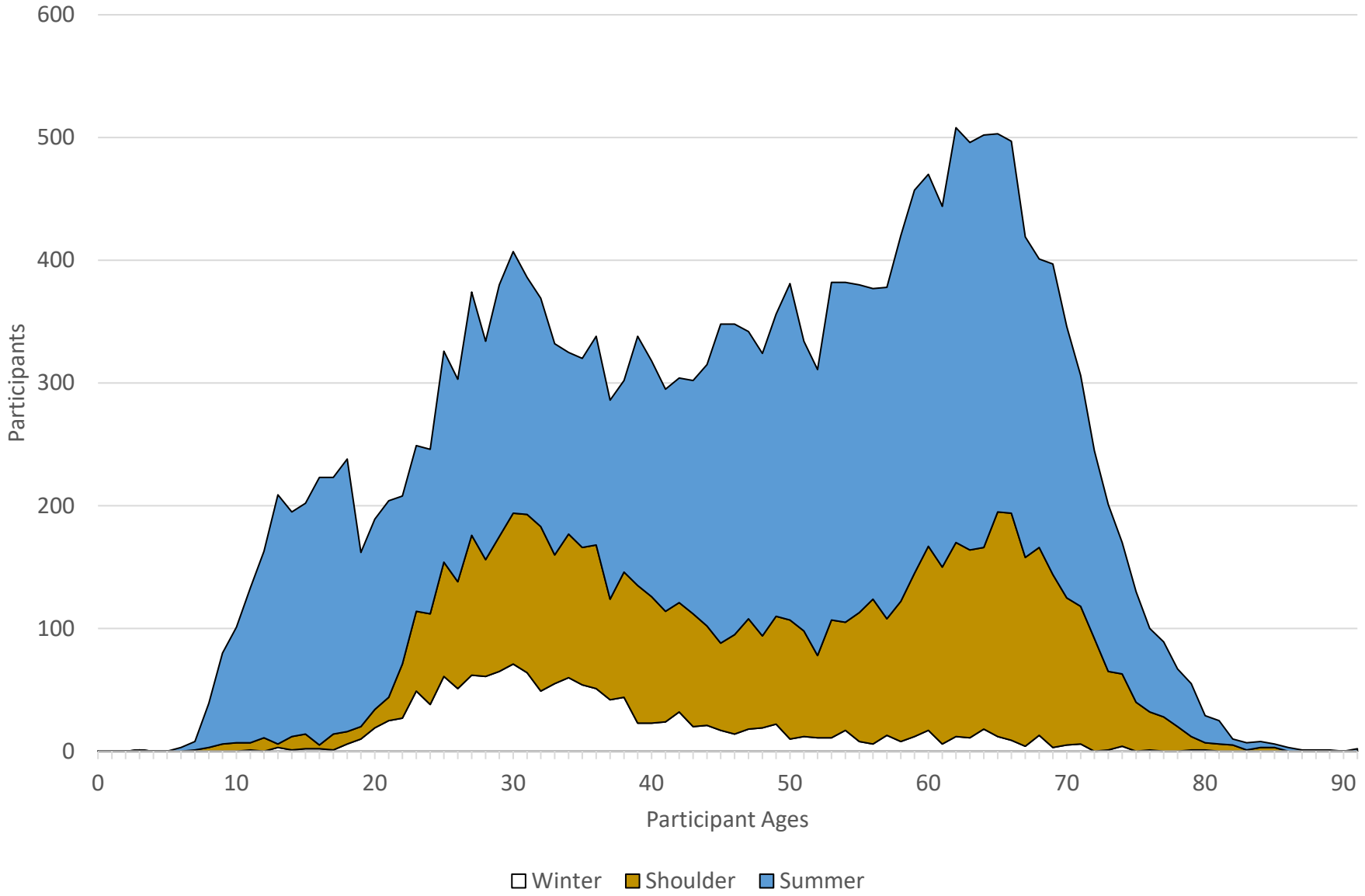
River – Lees Ferry to Diamond Creek Combined Total Use Passengers in 2024



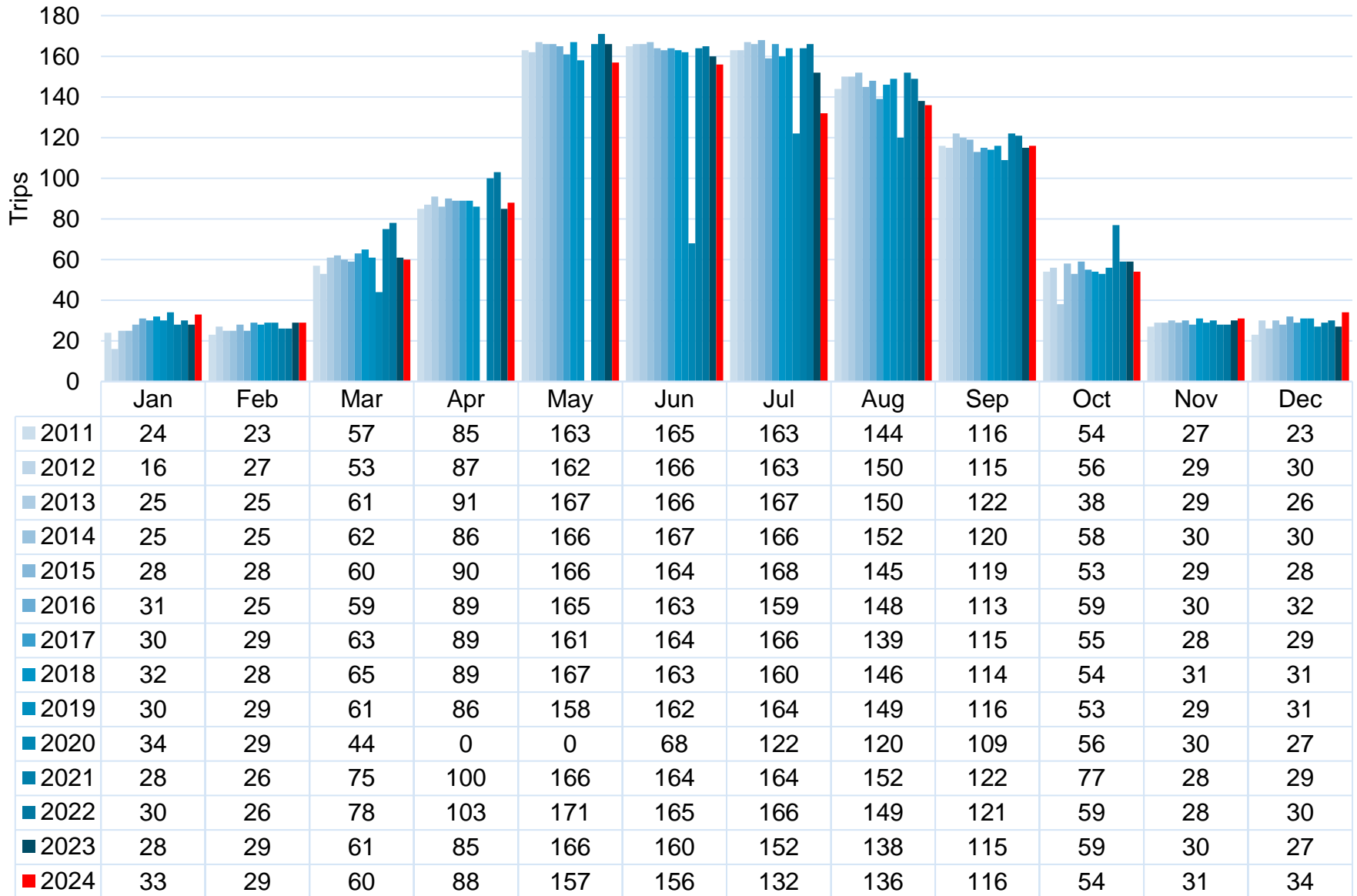

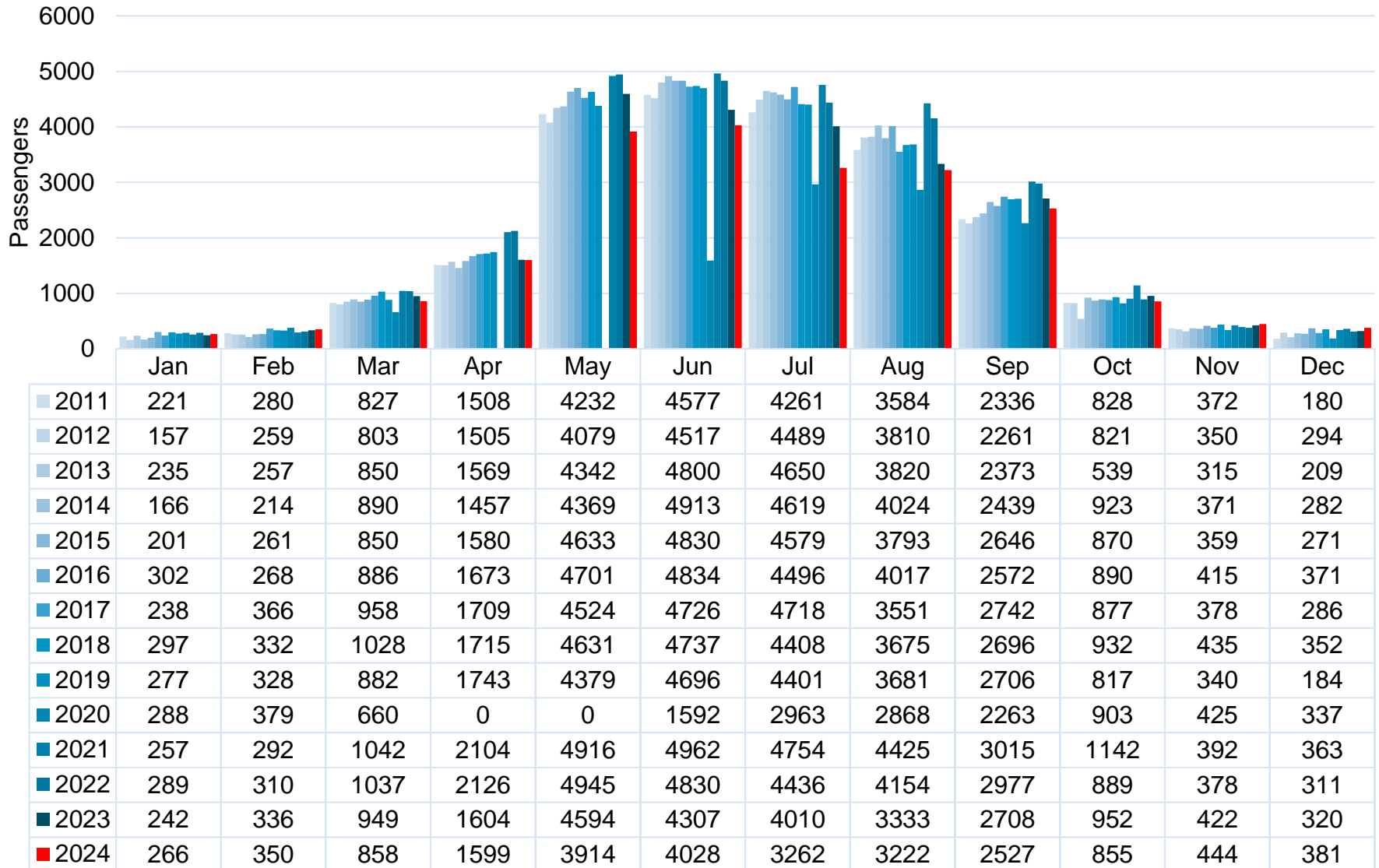

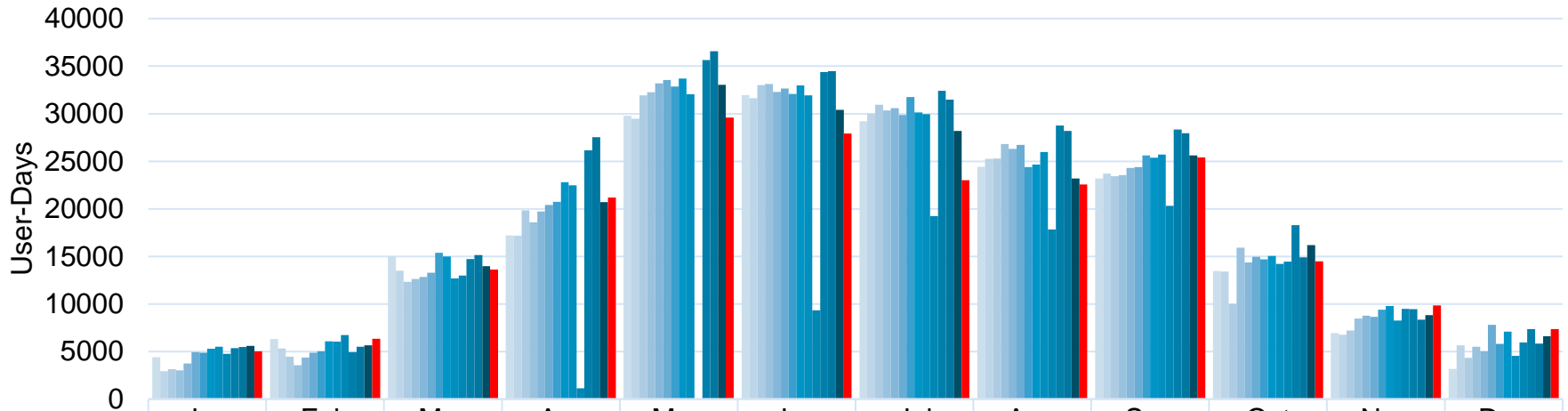

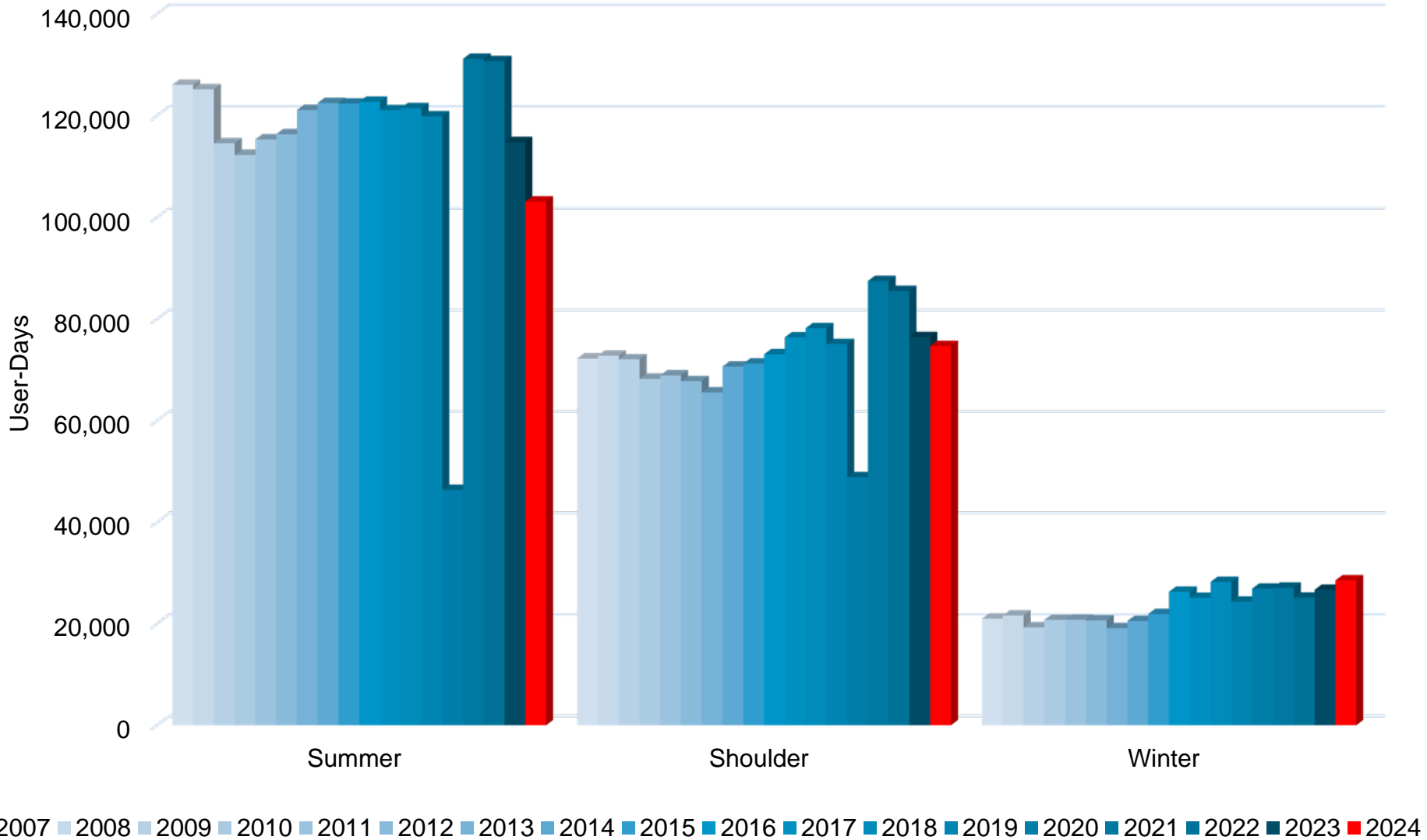

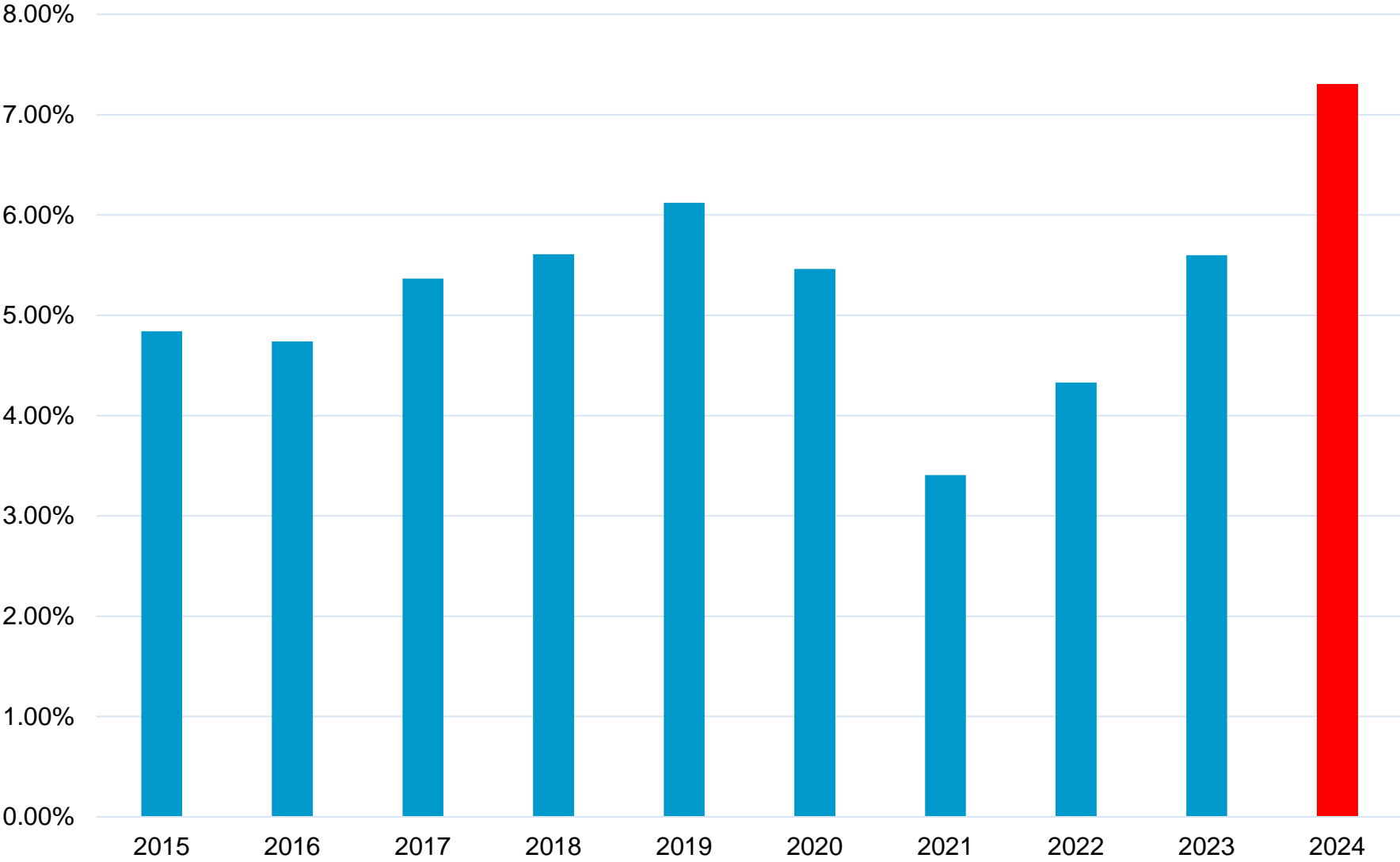

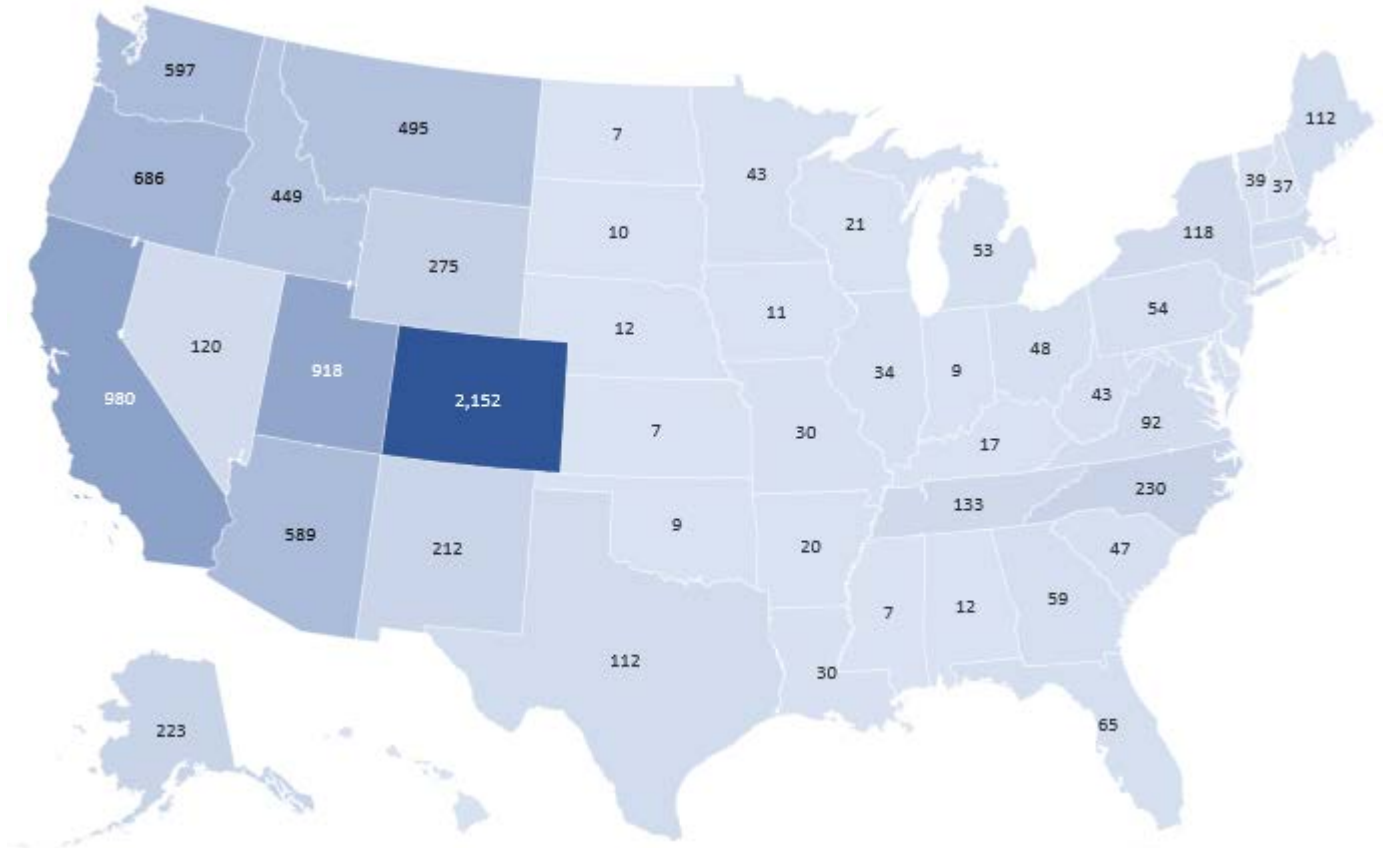
Noncommercial Weighted Lottery Percent of Foreign Applicants

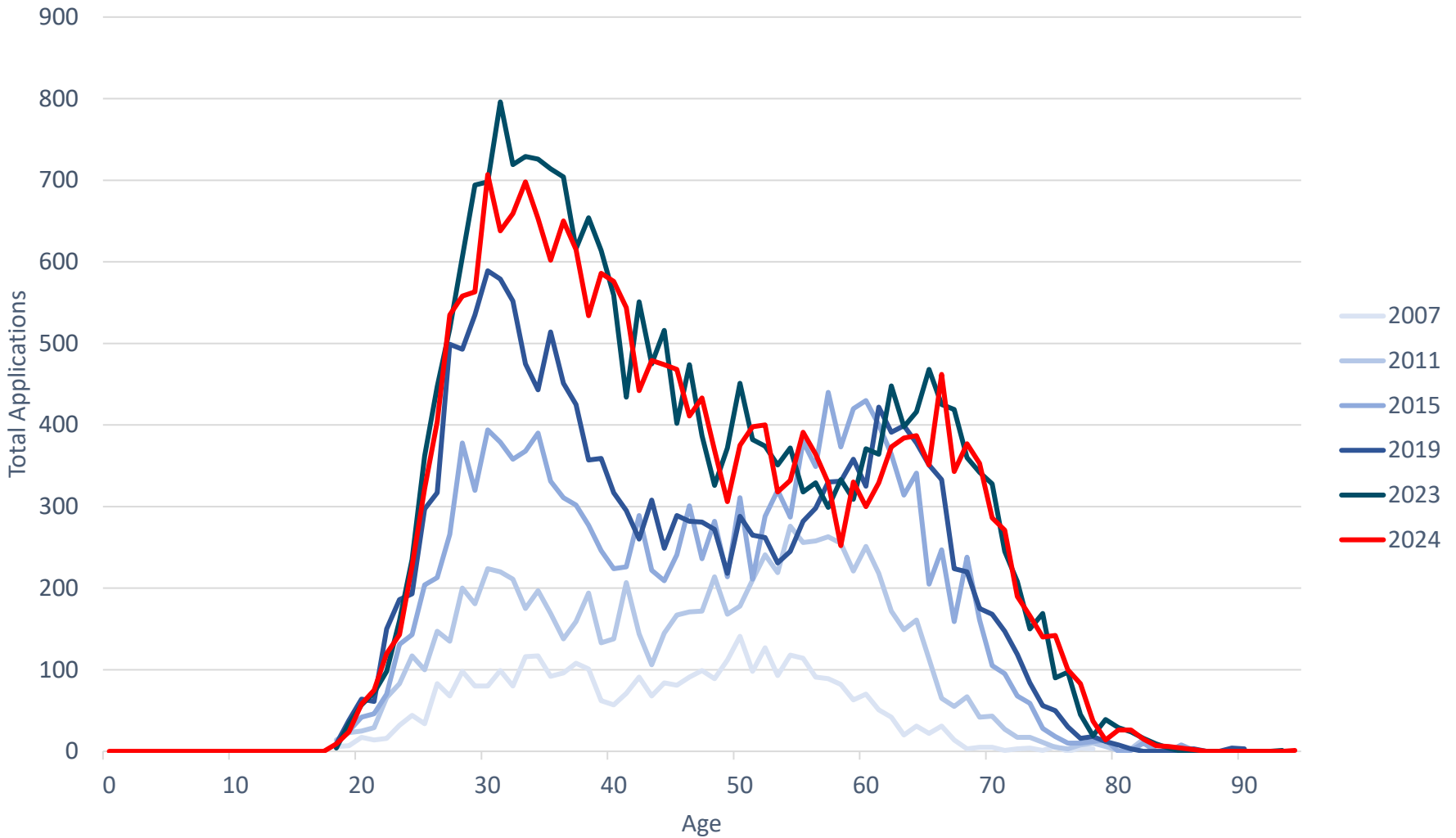

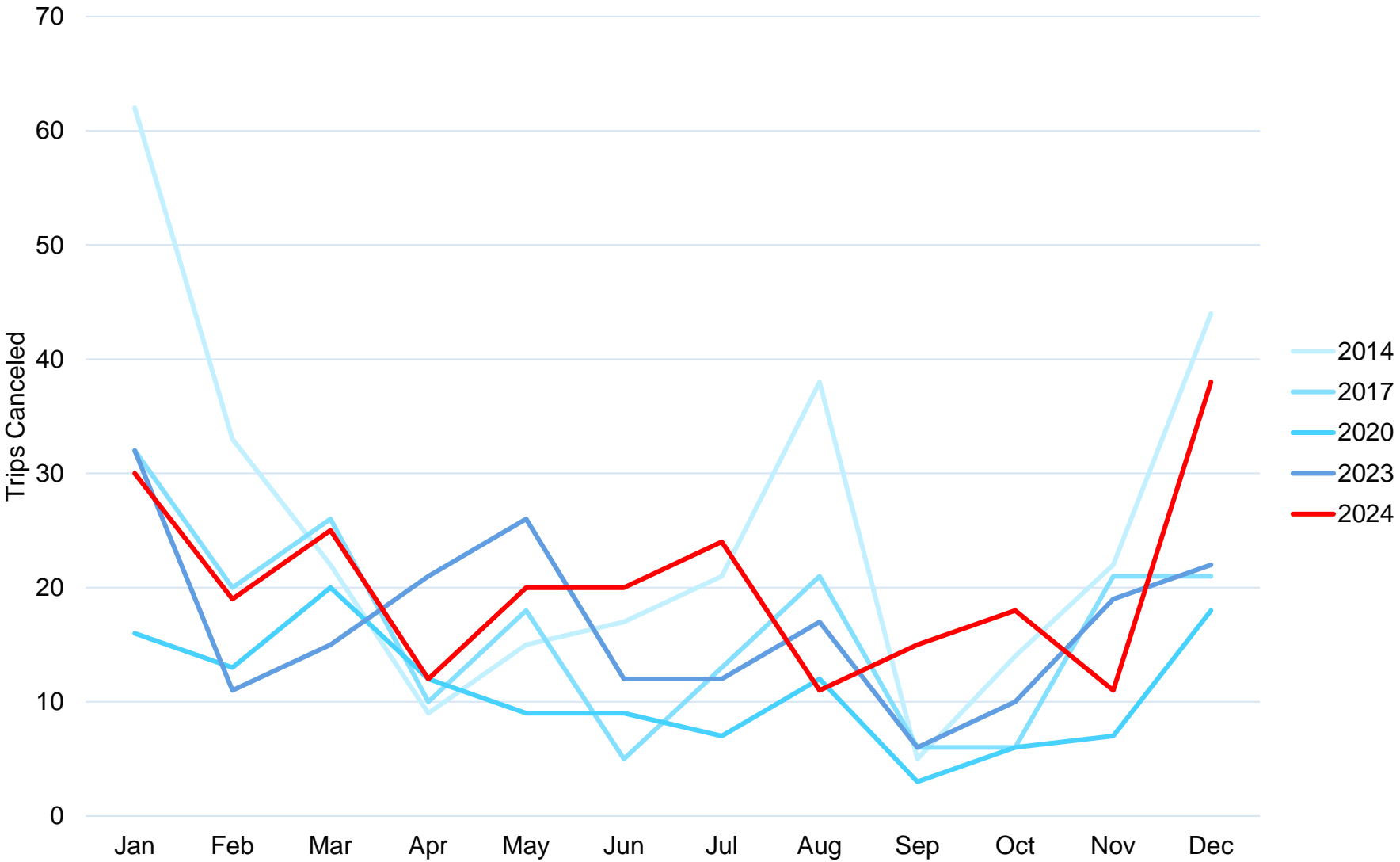

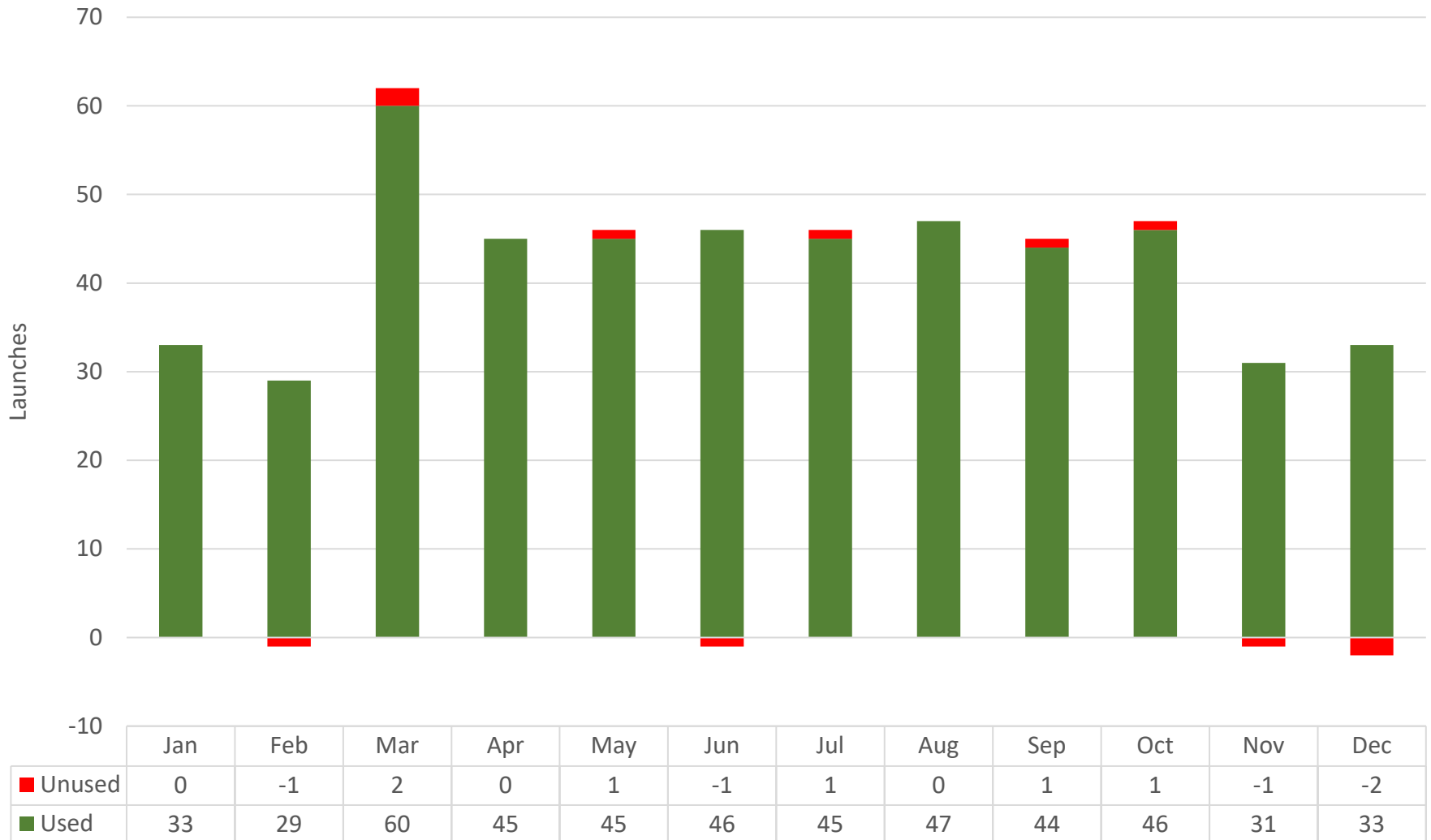

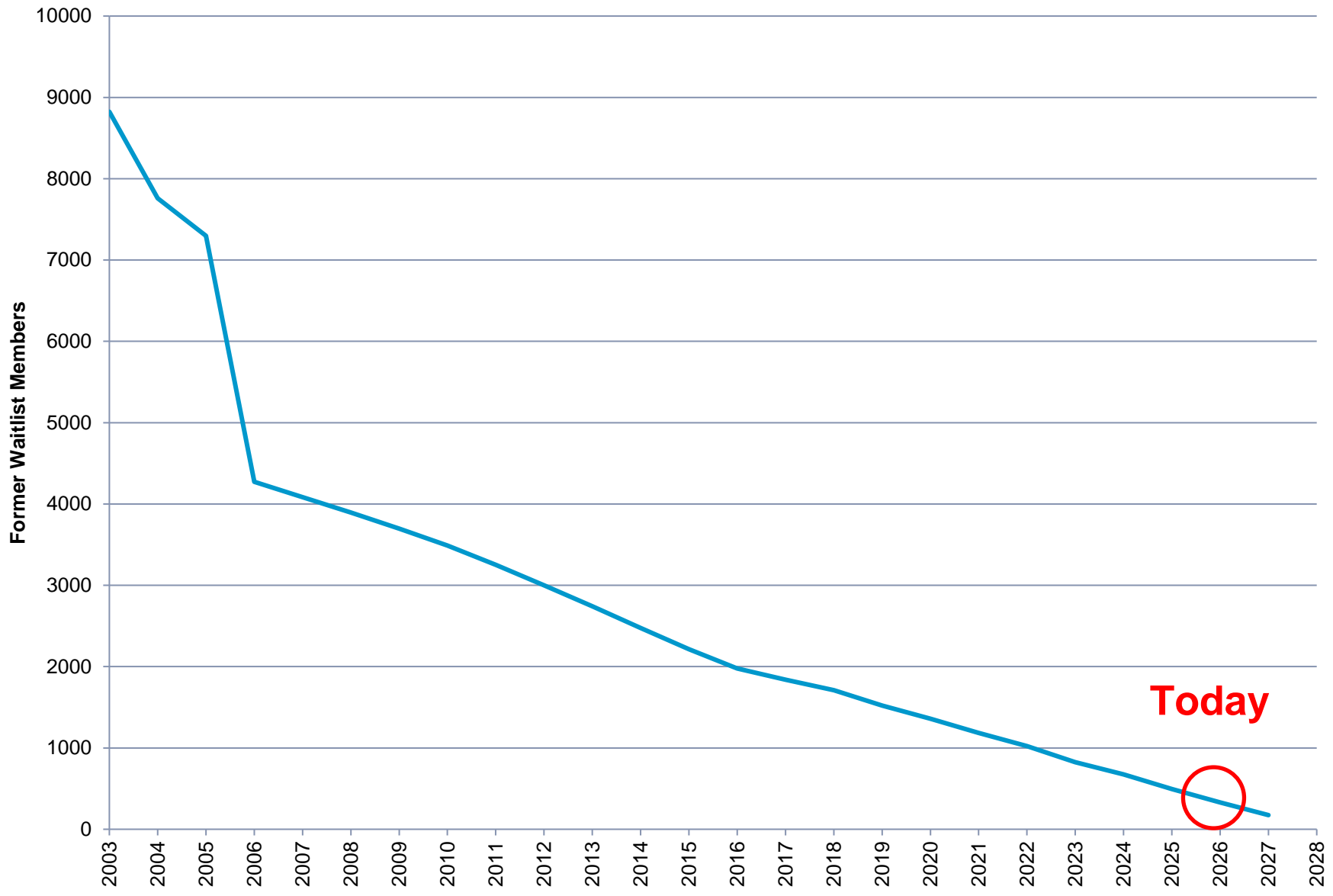
