## ***HISTORY***

Facilities Management is responsible for the management of the roads, trails, and structures which have been built at Haleakalā National Park since its establishment as a section of Hawaii National Park by Congress under the authority of the Antiquities Act in 1916. In the early 1930s, increased visitation to the Haleakalā Section necessitated the establishment of a road to the summit. Built in such a way that the crater would remain hidden until vehicles reached the top, the road was officially opened in 1935. In 1933, under the authority of the Emergency Conservation Work Act, President Franklin D. Roosevelt established the Civilian Conservation Corps (CCC) in order to give young men jobs and a source of income during the Great Depression. From 1934 to 1941, the CCC operated camps at Haleakalā. They completed natural resource conservation projects and toiled to improve public works. From 1941 to 1946, in response to World War II, Haleakalā was used by the military. An army base camp was built near Pu'uniauniau and various radar systems were installed at the summit. Most of the military buildings and installations have since been removed, but some are still used by park staff to this day. From 1956 to 1966, a ten-year development project known as Mission 66 enabled the improvement and construction of infrastructure in national parks across the country. Under this program, Haleakalā National Park was able to construct both a new park headquarters in 1958 and the Red Hill Observatory in 1963.

*DESCRIPTION* This collection contains records pertaining to facilities management at Haleakalā National Park. Materials include building project reports, road project reports, trail project reports, guardrail project reports, sign project reports, utility project reports, correspondence, drawings, and photographs. These records serve as an administrative record of facilities management conducted at Haleakalā National Park. The collection dates from 1911 to 2017. Some of the material is undated. The bulk of the material dates from 1950 to 2000. Records are kept as they relate to the natural and cultural resources in the park. All other records are preserved by the National Archives and Records Administration (NARA).

*ORGANIZATION* The collection is arranged into three series: Series 01: Buildings and Facilities, Series 02: Roads and Trails, and Series 03: Utilities. Series 01 is arranged numerically by building number. File units covering multiple buildings and building numbers can be found at the beginning of the series. Series 02 is arranged into 5 subseries: Roads, Trails, Entrances, Guardrails, and Signs. Roads, Entrances, Guardrails, and Signs are arranged chronologically by project. Trails is arranged alphabetically by trail name. Series 03 is arranged alphabetically by utility service. File unit numbers denote the location of materials and are assigned BOX.FOLDER.

*PROVENANCE* The materials in this collection were created by Hawaii National Park (pre-1961) and Haleakalā National Park (1961 to the present).
