



## ***Environmental Planning and Compliance Branch***

### **Program Overview**

The Environmental Planning and Compliance (EPC) program supports parks, regions, and WASO offices in the process of completing National Environmental Policy Act (NEPA) planning documents (Environmental Impact Statements and Environmental Assessments) with a priority emphasis on planning efforts that are court-ordered, likely to be litigated, precedent-setting, or of a complex or controversial nature. These planning and compliance actions relate to major management decisions that do not fit within the normal scope of the construction program or the general management planning program.

Inadequate NEPA planning can result in both poor decision making and court challenges that stop or redirect NPS actions. The support of legally defensible NEPA analyses that facilitate sound decision making is a primary function of the EPC program.

The EPC program also provides technical assistance and advice to parks, regions and other WASO offices on NEPA-related matters, serves as the Servicewide focal point for matters concerning NEPA, develops guidance and provides parks and regions with environmental planning and compliance training.

### **Highlights and Accomplishments**

#### ***Revised DO-12 Handbook and Delivering NEPA Training to Regions and Parks***

The EPC program issued a revised NPS NEPA Handbook with accompanying supplemental guidance in the fall of 2015. A new training program is being developed with the goal of educating practitioners in each region in 2016. In addition, EPC provides NEPA guidance and technical assistance on a daily basis to park, region, and WASO staff.

#### ***Addressing Servicewide Ungulate Management Issues***

The EPC program is currently managing six plans focused on ungulate management. Plans involving bison are underway at Grand Canyon NP, Great Sand Dunes NP/Preserve, and Yellowstone NP. A Grazing Management Plan is being developed at Capital Reef NP. Plans involving elk and mountain goats are occurring at Point Reyes NS and Olympic NP, respectively.

#### ***Wildlife Management Issues***

The EPC program is working on two wildlife management plans involving the reintroduction of predators. North Cascades NP is evaluating whether to reintroduce the grizzly bear to the park. Isle Royale NP has initiated an EIS to decide whether to reintroduce gray wolves to the island.

#### ***Wilderness and Visitor Use Planning***

The EPC program recently completed a wilderness stewardship plan for Sequoia/Kings Canyon NP and is currently managing the compliance processes for wilderness stewardship plans at Isle Royale NP and Mt. Rainier NP. EPC is leading the development of a water resources management plan in wilderness for Mojave National Preserve as well. Coordination discussions are ongoing with the NPS Wilderness Stewardship Division regarding meeting certain conditions of the Wilderness Act in concert with NEPA and other planning processes.

#### ***Managing and Regulating Off Road Vehicle Use***

The EPC program recently completed two off road vehicle (ORV) management plans and is currently managing ORV planning and rulemaking processes in three park units, including Glen Canyon NRA, Cape Hatteras NS and Cape Lookout NS. These plans will ensure that ORV use is managed in such a manner that protects natural and cultural resources and provides for the safety of park visitors and staff.
