

DESIGNATED 1ST AMENDMENT AREA FOR PIPE SPRING NATIONAL MONUMENT

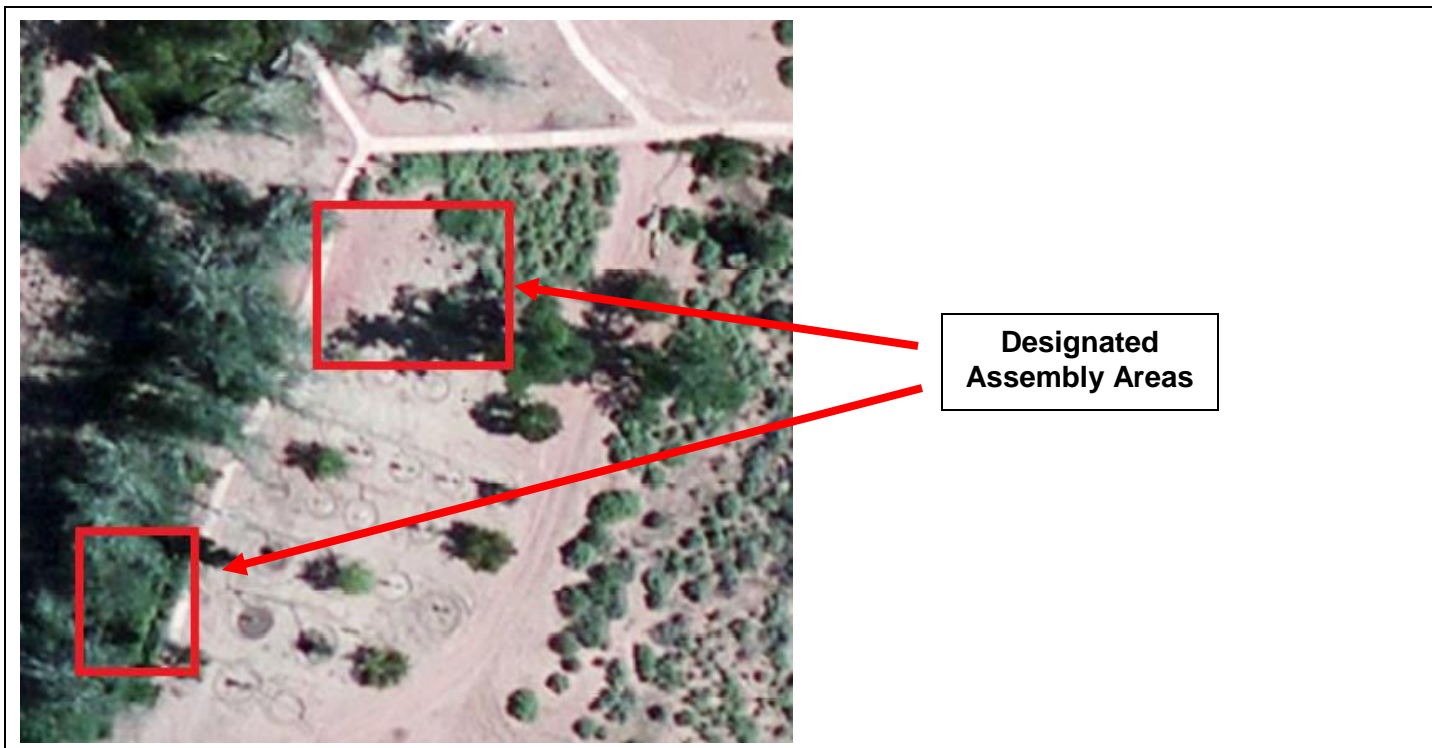
Site Identified: Designated areas of the Pipe Spring Orchard to include the Grape Arbor is designated a first amendment site at Pipe Spring National Monument (the Monument) in accordance with 36 CFR 1.5, 1.7, 2.51 and 2.52.

NPS Management Policies 2006 states “The National Park Service will authorize the use of park land for public assemblies, meetings, demonstrations, religious activities, and other public expressions of views protected under the First Amendment of the U.S. Constitution, in accordance with 36 CFR 2.51. Locations that are available for public assemblies and other First Amendment activities, including the sale and distribution of printed matter, will be designated by the superintendent on a map in accordance to 36 CFR § 1.5, 1.7, 2.51 and 2.52.”

Regulation 36 CFR §2.51 (b) Permits and the small group permit exception. Demonstrations are allowed within park areas designated as available under paragraph (c)(2) of this section, when the superintendent has issued a permit for the activity, except that:(1) Demonstrations involving 25 persons or fewer may be held without a permit within designated park areas, provided that:(i) None of the reasons for denying a permit that are set out in paragraph (f) of this section are present;(ii) The group is not merely an extension of another group already availing itself of the small group permit exception under this provision;(iii) They will not unreasonably interfere with other permitted demonstrations and special events, or park program activities; and(iv) Hand-carried signs may be used, but stages, platforms, or structures may not be used.(2) While it is not mandatory, the organizer is requested to provide reasonable notice of the proposed event to the park superintendent, including whether there is any reason to believe that there may be an attempt to disrupt, protest, or prevent the activity.

Regulation 36 CFR §2.52 (b) Permits and the small group permit exception. The sale or distribution of printed matter is allowed within park areas designated as available under § 2.51(c)(2) when the superintendent has issued a permit for the activity, except that:(1) Sale or distribution activity by 25 persons or fewer may be conducted without a permit within designated park areas, provided that:(i) None of the reasons for denying a permit that are set out in paragraph (e) of this section are present;(ii) The group is not merely an extension of another group already availing itself of the small group permit exception under this provision;(iii) The sale or distribution will not unreasonably interfere with other permitted demonstrations and special events, or program activities; and(iv) Hand-carried signs may be used, but stages, platforms, or structures may not be used.(2) While it is not mandatory, the organizer is requested to provide reasonable notice of the proposed event to the park superintendent, including whether there is any reason to believe that there may be an attempt to disrupt, protest, or prevent the activity.





COMPLIANCE MEASURES:

- No sound amplification is allowed. Vocal communication with or to the public shall not exceed normal conversational volume. Shouting or raising voice volume to call the attention of the public is prohibited.
- No changes or modifications (to include signs / decorations) are authorized in any area of the Orchard / Grape Arbor.
- All first amendment activities must take place during posted hours of operation. First Amendment Activities and persons associated with first amendment activities may not enter Pipe Spring Premises before the Monument's posted opening time. First Amendment Activities must conclude before the Monument's posted closing time. All persons associated with first amendment activities must vacate the Monument before the posted closing time.
- The first amendment site can accommodate one first amendment group at a time. In the event that two or more groups wish to utilize the Monument for first amendment activities at one time, the Superintendent or designee should be contacted to make other arrangements.
- The use of the National Park Service Arrowhead logo is not authorized.
- Utmost care will be exercised to see that no natural, historic or cultural features are injured, and after completion of the event area will either be cleaned up and restored to its prior condition or left, after clean-up, in a condition satisfactory to the official in charge.
- Nothing shall be attached to any natural or historic object, or any National Park Service sign, bench, post, building or facility. No banners, steamers or hanging objects will be allowed.
- Permittee is allowed to have 2 standing signs at the demonstration site. At no time will the Permittee(s) block any entrance to nearby buildings, or in any way obstruct or make it difficult for other individuals to enter these buildings.
- The designated area shall remain open to park visitors. Park visitors shall not be requested to move themselves, their vehicles or alter their selected activities by the Permittee.
- Noncommercial solicitation is specifically authorized under 36 C.F.R. § 2.37, if it is conducted under a public assembly permit. Permittee is permitted to request donations in support of their cause.
- Persons engaged in this activity are prohibited from obstructing or impeding pedestrians or vehicles, harassing park visitors or residents with physical contact or persistent demands, misrepresenting the purposes or affiliations of the persons engaged in the distribution, or misrepresenting whether the printed matter is available without cost or donation.
- Any special instructions received from the official in charge of the area will be complied with.
- Group size does not exceed (NTE) 25 Persons.
- Site is only available when not in use for NPS programs, activities, or other permitted activities.

Special Use Permit is required under the following circumstances:

- A first amendment group wishes to have priority of the first amendment site.
- The first amendment activity would not meet all of the compliance measures including having a group size of more than **25 people**.
