Barrows [sic] Company (F) Ninth Regiment of Michigan Infantry VOLUNTEERS who was enrolled on the Fourteenth day of August one thousand eight hundred and Sixty one to serve three years or during the war, is hereby Discharged from the service of the United States, this Twenty Seventh day of November 1863, at Chattanooga Tennessee by reason of Reenlistment as a Veteran Volunteer

(No objection to his being reenlisted is known to exist.)[see footnote below]

Said Arthur B. Hathaway was born in Livingston Co in the State of Michigan, is Twenty One years of age, Five feet Nine and 1/2 inches high; light complexion, Blue eyes, Brown hair, and by occupation, when enrolled, a Blacksmith.
