Declaration for Invalid Army Pension

## DECLARATION FOR INVALID ARMY PENSION.

State of Indiana

County of Clinton SS:

On this 15th day of April, A. D. on thousand eight hundred and sixty [crossed out] 71, personally appeared before me, Dewitt I. Bryant, Clerk of the Circuit Court within and for the County and State aforesaid, John F. Crick aged 32 years, a resident of Perry Township, in the County of Clinton, in the State of Indiana, who, being duly sworn, according to law, declares he is the identical John F. Crick, who enlisted in the service of the United States at Stockwell, County of Tippecanoe, State of Indiana, on the 19th day of August, in the year 1862, as a Private in Company "I" commanded by Captain

Wm. C. Lambert in the 86th Regiment of Indiana Inf. [sic] Vols, in the War of 1861, and was Transferred to Invalid Corps Co. "I" 17th Regt. Vet. Res. Corps and was honorably discharged on the 30th day of June, in the year 1865; that while in the service aforesaid, and in the line of his duty, at a place called Stone [sic] River, in the State of Tennessee, on the 31st day of December, 1862, he was wounded by a musket ball in the right hip at which time I was taken prisoner and abandoned by the enemy and then taken to Hospital No. 19 at Nashville Stat [sic] of Tennessee and recovered there until about the 15th of January from then marine Hospital at Cincinnati Ohio and remained there until about the last of February or 1st March from there to Soldier Home at Indianapolis and remained there until mustered out of the service.

Since leaving the service he has resided Perry Township in the County of Clinton, in the State of Indiana and his occupation has been Farmer when enrolled he was a Farmer. And for the purpose of prosecuting his claim [end of file]
