CERTIFICATE OF DISABILITY FOR DISCHARGE.

(To be used, in duplicate, in all cases of discharge on account of disability.)

Jacob T. Hunt a private of Captain Woods Company, (C) of the 34th Illinois Regiment of United States Col. [illegible] was enlisted by A.P. Dysant Capt [sic] of the 34th Regiment of Ill, [illegible] at Franklin Grove Ill on the 2nd day of September 1861, to serve three years; he was born in Delaware [sic] Co in the State of New York is 23 years of age, 5 feet 4 inches high, Sandy complexion grey eyes, Brown hair, and by occupation when enlisted a Farmer. During the last two months said soldier has been unfit for duty [blank] days. (Here consult directions on Form 13, p. 325, Medical Dept. Gen. Reg.)

This man was wounded at battle of Stone [sic] river, the ball entered three inches below Coracoid [illegible] left shoulder, and passing out through capula, [sic]

I CERTIFY, that I have carefully examined the said Jacob T. Hunt of Captain Woods Company, and find him incapable of performing the duties of a soldier because of (Here consult par. 1260, p. 284, and directions on Form 13, p. 395, Med. Dept. Gen. Reg.) A. gunshot wound of left shoulder, causing atrophy of muscles of joint and rendering him unable to rotate or elevate the left shoulder Degree of disability 1/3

Know Ye, That Jacob T. Hunt a private of Captain Benson Wood (C) Company, 34th regiment of [illegible] Ill Vols. who was enrolled on the Second day of September, one thousand eight hundred and sixty one to serve three years is hereby DISCHARGED from the service of the United States this 17th day of March 1863, at Cincinnati Ohio by reason of Surgeon Certificate of Disability under Genl [sic] orders Nos. 36 and 65 Series of the War Department. No objection to his being re-enrolled is known to exist. [last sentence was crossed out]

Said Jacob T. Hunt was born in Delaware [sic] in the State of New York, is twenty three years of age, five feet four inches high, Sandy complexion, Grey eyes, Brown hair, and by occupation, when enrolled, a Farmer

Given at Cincinnati Ohio this 17th day of March 1863
