Jas. J. Martin and James F. [illegible], of said State and County, having been presented as a witness in support of the application of Mrs. E C Lane Widow of H.S. Lane for a Pension under Chapter 202, Acts of 1905, and after being duly sworn true answers to make to the following questions, deposes and answers as follows:

1. What is your name and where do you reside? Jas Jasper Martin Rock Island RFD #2 and James F. [illegible] Rock Island R.F.D. No 2
2. Are you acquainted with the applicant, Mrs. Mrs [sic] E C Lane If so, how long have you known her? Ever since before she was married and Jas T [illegible] says ever since 1859
3. Where does she reside, and how long and since when has she been a resident of this State? She lives at [illegible], and has been a resident of the state all her life
4. When and where was she born? Born in White [illegible] Tenn [sic] 1836
5. Were you ever acquainted with her husband? Yes James T [illegible] says they were married and living as man and wife in 1859.
6. When and to whom was he married? 1855, he married to E.C. Haltman
7. When and where was he born? Don't know when; was born in Van [illegible] Co
8. How long have you known him? 50 years or more. Was raised together [illegible] [illegible] say from 1859 to his death
9. When and where did H.S. Lane enlist in the war between the States, and in what Company and Regiment did he enlist, and how do you know this? Enlisted in Co. "D" 16th Tenn. 1862 at Murfreesboro Was member of same regiment and present when he enlisted [written on left margin of paper] James T. [illegible] [illegible] H.S. Lane enlisted [illegible] [illegible] he [illegible] Tenn [sic] Co "D". O.H. Coffee affirmed Capt [sic] House [illegible] 16th Regt [illegible] [illegible] C. Nov. or [illegible] 1862. He was only in service about 45 [illegible] He was killed at battle Murfreesboro Tenn [sic] [three illegible words]

I was member same Co and Regt and [illegible] and late in [illegible] I got [illegible] of Col Savage and [rest is illegible]

10. Were you a member of the same Company and Regiment? Was a member of Donalds Co same regiment Jas. T. [illegible] was member of Capt [sic] [illegible] Coffees [sic] Co afterwards commanded by Capt [sic] H. [illegible]

11. How long did he perform regular military duty? Not very long He went into [three illegible words] battle and got killed James T. [illegible] thinks it only 40 days until he was killed in said [illegible]

12. When and where was his Company and Regiment surrendered? Do not know [illegible] Jas [illegible] says he was Nashville his command at surrender

13. Were you with the command when it surrendered? No I got [illegible] in Winter of 64-5 and was absent at time of surrender No

14. Was [blank] the [illegible] of applicant present? [blank]

15. If not present, where was he? killed in Murfreesboro battle

16. When and where did he leave his command? [blank]

For what cause? [blank]

By whose authority he left? [blank]

How do you know all this? (state facts and [illegible]) I saw Harden S. Lane after he was killed at battle of Murfreesboro. I was his neighbor, knew him well and was certain it was Harden Lane

17. When and where did Harden S. Lane die? [illegible] last day of battle of Murfreesboro, on battle field I saw him dead on battle field

18. Where did he reside at his death and how long had he been a resident of Tennessee at his death? Resided in Warren Co Tenn, [sic] and had been resident of state all his life

19. Do you of your [illegible] knowledge know that applicant is the lawful widow of H.S. Lane? Know that he and she lived together [illegible] his wife bore 4 children and were treated and regarded as man and wife in the community. James T. [illegible] says his last child was born in March 1863 after his death in Dec 1862.
