I, William Logan, born in Davis Co. in the State of Indiana age 23 years, and by occupation a [illegible] DO HEREBY ACKNOWLEDGE to have volunteered this 23rd day of August 1862 to serve as a Solider in the Army of the United States of America, for the period of THREE YEARS, unless sooner discharged by proper authority: Do also agree to accept such bounty, pay, rations, and clothing, as are, or may be, established by law for volunteers. And I, William Logan do solemnly swear, that I will bear true faith and allegiance to the United States of America, and that I will serve them honestly and faithfully against all their enemies or opposers whomsoever; and that I will observe and obey the orders of the President of the United States, and the orders of the officers appointed over me, according to the Rules and Articles of War.

Sworn and subscribed to at Washington, Ind this 23 day of August 1862
