On this the twenty-second day of February AD 1871 personally appeared before me Charles H Morton a duly authorized officer of a Court of Record in and for the County and State aforesaid Martha J. Hinson who being duly sworn according to law makes the following declaration in order to obtain the pension provided by Act of Congress for children under sixteen years of age, that she is the [illegible] legal guardian of Flora A Manlove, [illegible] child of Daniel R Manlove who enlisted under the name of Daniel R Manlove at [illegible] Adams Co Illis. [sic] on the 5th day of August AD 1862 in Co "I" 84th Regt Ill Inf Vols in the war of 1861, who died of wounds, at Nashville Tennessee on or about the 29th day of March AD 1863, and who bore at the time of his death the rank of private, that he left a widow Martha J. who has since married with Warren D Hinson on the [illegible few lines of text]

of August AD 1864 came personally before me Elizabeth Burke and John H Holton residents of Adams County, personally [illegible] to the undersigned to be respectable and entitled to credit, and being just and duly sworn according to law [illegible] [illegible] that Affiants have known Daniel R Manlove and his wife Martha J. for more than eight years, that they were not present at their marriage but know by general reputation that they were married as set forth in her declaration for a Pension Declarants have frequently visited the house and home of Daniel R Manlove after his marriage to Martha J Alexander and have every means of knowing that they lived together as husband and wife Declarants further state that they know and have examined the [illegible] Testament of Martha J. Manlove and so far as relates to the marriage of David R Manlove to Martha J. Alexander, the following is an exact copy of the record there foresaid. "Daniel R. Manlove was married to Martha J Alexander Feb 27 1861"

And so far as relates to the birth of their child, the following, "Flora Alice Manlove was born January 20. 1862"

Affiants further swear that they [illegible] as above stated, and have no interest in the prosecution of this Pension Claim either direct or indirect.

I, Albert J. Griffith do hereby certify that I am [crossed out] was Capt [sic] of Company "I" of the 84th Regiment of Illinois Volunteers, and am acquainted with David R Manlove who was a member of my Company, and as I am informed his widow is an applicant for an Invalid [crossed out] Pension. That the said David R Manlove was mustered into service on or about the [blank] day of [blank] 186[blank], and discharged for disability [crossed out] Death about the 29th day of March 1863, having become disabled from doing duty as a soldier from on or about the 1st day of January 1863, while in the service of the United States and in the line of his duty as a soldier, in the manner and at the place as follows: He was wounded in the Battle of Stone [sic] River by a gunshot wound in the right breast the ball passing near the collar bone, from which time he was in Hospital No 1. Nashville Tennessee

That the said soldier was in good health at the time he entered the service, and the disability above referred to affected him while in the service and at his discharge, as follows: He never recovered from the wound

"I", 84th Regiment of Illinois Volunteers, to serve 3 years, or during the war, and mustered into service as a Private on the 1st day of Sept, 1862, at Quincy Ill, in Co. "I", 84th Regiment of Illinois Volunteers, to serve 3 years, or during the war. On the Muster Roll of Co. "I" of that Regiment, for the months of May and June 1863, he is reported "Died in Hospital No 1. Nashville Tenn. March 29th 1863" "Cause of Death not stated"
