

W. H. McCauley Pension

CERTIFICATE

April 5, 1934.

This is to certify that the records of this office show that W. H. McCauley, Dickson County, Dickson, Tennessee, filed an application for Confederate Veteran's pension February 3, 1915, under number 14603.

Below is a statement of his Confederate service record as given by him in his application.

"I, W. H. McCauley, native of the State of Tennessee, resident at Dickson, Dickson County, Tennessee, do solemnly swear that I was born in Montgomery County, Tennessee, October 15, 1837. I enlisted in the Confederate Army in May, 1861, in Company C, 11th., Tennessee Infantry. I served under Will Green, Captain; J. E. Rains, Colonel. I was in the battles at Rock Castle, Kentucky, Murfreesboro, Tennessee, Chickamauga, Georgia, Missionary Ridge, Newhope [sic] Church, Kennesaw Mountain, Marietta, Peachtree Creek and Jonesboro, Georgia. I was wounded in my right side at Murfreesboro, Tennessee, December 31, 1862, captured and sent to prison. I was in prison at Camp Chase and Fort Delaware, and exchanged April, 1863. I surrendered with General J. E. Johnston's Army."

Below is a statement of Mr. McCauley's Confederate service record as furnished this office by the War Department, Washington, D.C., February 9, 1915.

"The records show that W. H. McCauley served as sergeant and as captain in Company C, 11th Reg't [sic] Tennessee Infantry, C.S.A., and that he enlisted May 14, 1861; that he was captured at Murfreesboro January 5, 1863; paroled at Ft. Delaware, Del., April 25, 1863, and received at City Point, Va., May 4, 1863. The records further show that he was again paroled at Greensboro, N.C., May 1, 1865, in accordance with the terms of the military convention of April 26, 1865."
