I CERTIFY, That the within named John Pollock a Private of Captain John M. Winstead's Company (B) of the Thirty second regiment of Tennessee Volunteers, born in Bedford Co. in the State of Tennessee, aged forty seven years, five feet, eight inches high, dark complexion, grey eyes, black hair, and by occupation farmer was enlisted by Capt. John M. Winstead at Pulaski Giles Co. Tenn [sic] on the seventh day of October 1861, to serve one year, and is now entitled to discharge by reason of the said John Pollock being over forty years of age and having served the full term he enlisted for.

The said John Pollock was last paid by Maj. A. Boyd to include the seventh day of June 1862, and has pay due from that date to the present date.

There is due to him [blank] Dollars traveling allowance from [blank], the place of discharge, to [blank], the place of enrolment, transportation not being furnished in kind.

There is due to him for clothing fifty dollars
