This roll is a transcript from the records of the Office of the Commissary General of Prisoners, Washington, D.C., and contains a list of prisoners of war appearing as still on hand at Nashville, Tenn. It was forwarded to the Provost Marshal General, Military Division of the Tennessee, Nashville, Tenn., July 11, 1865, with a statement that no report had been received showing what disposition had been made of them. The roll was returned September 10, 1865, with the reply that a report has been made under the column of Remarks showing the disposition made of such prisoners, whose names appear on the roll, as had been under the control of the Provost Marshal General. – M.S. 963447.
