Dear Mr. Chairman:

The Department of the Interior (DOI) is pleased to submit the enclosed report addressing Recommendations 1 and 2 of the Government Accountability Office (GAO) report entitled, *NATIVE AMERICAN GRAVES PROTECTION AND REPATRIATION ACT: After Almost 20 Years, Key Federal Agencies Still Have Not Fully Complied with the Act* (Report No. GAO-10-768). These two recommendations require a report to Congress.

Recommendation 1 requires a needs assessment for each involved DOI bureau and office to assure compliance with the summary and inventory requirements of the Native American Graves Protection and Repatriation Act (NAGPRA). Recommendation 2 requires a timetable for the expeditious publication of notices of inventory completion for known culturally affiliated remains in inventories yet to be published in the *Federal Register*.

This report is being submitted to the Senate and House Appropriations Subcommittees on Interior, Environment, and Related Agencies; the Senate Committee on Indian Affairs, and the House Natural Resources Subcommittee on Indian and Alaska Native Affairs.

AFTER ALMOST 20 YEARS, KEY FEDERAL AGENCIES
STILL HAVE NOT FULLY COMPLIED WITH THE ACT*
(REPORT NO. GAO-10-768)**

AUGUST 2011

The Native American Graves Protection and Repatriation Act of 1990 (NAGPRA) requires Federal agencies and museums to prepare summaries and inventories of their collections for Native American human remains, funerary objects, sacred objects, and objects of cultural patrimony (cultural items); research and consult with tribes to identify lineal descendants and culturally affiliated groups; and upon a valid claim, repatriate to the appropriate parties.

In July 2010, the Government Accountability Office (GAO) issued the report entitled, *NATIVE AMERICAN GRAVES PROTECTION AND REPATRIATION ACT: AFTER ALMOST 20 YEARS, KEY FEDERAL AGENCIES STILL HAVE NOT FULLY COMPLIED WITH THE ACT* (Report No. GAO-10-768). This report brought attention to concerns with Federal agency compliance with NAGPRA, including the bureaus and offices within the Department of the Interior (DOI). The GAO study offered five recommendations for executive action, responses to two of which are presented in this report.

One recommendation requires a needs assessment for each involved DOI bureau and office to assure compliance with the summary and inventory requirements of the Native American Graves Protection and Repatriation Act (NAGPRA). The second recommendation requires a timetable for the expeditious publication of notices of inventory completion for known culturally affiliated remains in inventories yet to be published in the Federal Register. Both recommendations require that DOI report to Congress. This report summarizes the overall DOI position, including the responses of the following DOI bureaus and offices:

- Bureau of Land Management (BLM)
- Bureau of Reclamation (BOR)
- Indian Affairs (IA), includes the Bureau of Indian Affairs and Bureau of Indian Education
- Indian Arts and Crafts Board (IACB)
- National Park Services (NPS)
- U.S. Fish and Wildlife Service (FWS)

GAO Recommendation 1: *The Secretary of the Interior should direct the cultural resource management programs to develop and provide to Congress a needs assessment listing specific actions, resources, and time needed to complete the inventories and summaries required by NAGPRA sections 5 and 6 for their historical collections.*

To address this recommendation, each DOI bureau and office that has possession or control over Native American cultural items in their collections prepared a needs assessment. The needs assessments list specific actions, resources, and time needed to complete inventories and summaries of Native American cultural items.

Currently, DOI bureaus and offices utilize \$1.42 million for these NAGPRA activities. The results of the needs assessments shows that DOI requires an additional \$3.34 million annually for bureaus and offices to complete compliance with sections 5 and 6 of NAGPRA, and a minimum of eight years to complete specific tasks. However, on-going work in this area will be necessary.

Generally, all bureaus and offices have completed summaries and inventories for known collections – primarily those that are within the control of these Federal entities. Additional work is necessary to locate items in collections that are housed in non-federal museums, universities, historical societies and other organizations (repositories). These items would have been removed from DOI-managed lands between 1906 and 1990. As collections are located in these repositories, DOI bureaus and offices will complete the necessary summaries and inventories in accordance with the timelines prescribed in 43 CFR Part 10.13, *Future Applicability*.

The following tables provide more detail on specific actions, time, and funding necessary for each bureau and office to complete inventories and summaries of Native American cultural items. Also provided is information on actions that are planned to be funded by bureau and office programs.

DEPARTMENT OF THE INTERIOR CONSOLIDATED NEEDS ASSESSMENT

THE BUREAU OF LAND MANAGEMENT– The BLM’s Cultural Resources Management Program maintains a modest, but active, NAGPRA compliance component. The BLM has reported all known NAGPRA collections in inventories. All culturally affiliated Native American human remains and cultural items have been published in the Notices of Inventory Completion in the *Federal Register* or are in the NPS National NAGPRA Office queue for publication. The BLM’s principle concern is to ensure full compliance with NAGPRA’s requirements for summaries and inventories involving unknown collections in the possession of non-federal repositories. There may be collections recovered since 1906 from BLM public lands or its predecessor agency, the General Land Office (GLO) that are in the possession of non-federal repositories, but unknown to the BLM. The BLM continues to improve its accountability over and coordination of museum collections managed by non-federal repositories that were recovered from the BLM or GLO lands. Any previously unreported NAGPRA cultural items that are located in collections and identified to be in the control of the BLM are handled by the Bureau pursuant to the Future Applicability Rule (43 CFR 10.13). This rule also applies to new collections acquired by the BLM that did not originate from BLM lands, such as those seized and forfeited as part of law enforcement activities.

BUREAU OF RECLAMATION – In general, the Bureau of Reclamation is compliant with Sections 5 and 6 of NAGPRA. Four of Reclamation’s five regions have minor issues to resolve regarding summaries, inventories, and repatriations for the NAGPRA cultural items and human remains that still remain under their control. The Mid-Pacific Region has major work to accomplish to determine ownership of NAGPRA items and Native American human remains located in non-Federal repositories, complete inventories and summaries, consult with affected tribes and individuals, determine cultural affiliation, secure the items, and transfer custody.

Note: All agencies included in this report, excluding the Bureau of Reclamation, are under the jurisdiction of the Interior and Environment Appropriations Subcommittee. The Bureau of Reclamation is under the jurisdiction of the Energy and Water Development Subcommittee.

INDIAN AFFAIRS – The Museum Program within the Division of Environmental and Cultural Resources Management, in the Office of Facilities, Environmental and Cultural Resources, in Indian Affairs provides oversight for all NAGPRA activities to ensure compliance with Sections 5-7 of NAGPRA. All culturally affiliated Native American human remains and cultural items over which IA asserts control have been published in Notices of Inventory Completion in the Federal Register or are in the NPS queue for publication. IA’s archaeological collections, which include NAGPRA cultural items, are primarily housed in non-IA repositories, typically in museums and universities. IA maintains contact with all known repositories that currently house IA collections. NAGPRA cultural items, over which IA asserts control, that are identified in museum collections are handled pursuant to the Future Applicability Rule (43 CFR 10.13). Therefore, while IA continues to fund NAGPRA projects in its known repositories as budgets permit, IA still needs to identify all other repositories which house NAGPRA cultural items removed from Indian lands between 1906 and 1979.

INDIAN ARTS AND CRAFTS BOARD – The IACB’s NAGPRA compliance efforts are part of its overall museum program. To achieve full compliance with NAGPRA, funding and staff time have been shifted from the agency’s Indian Arts and Crafts Act (law enforcement) and economic development programs to address outstanding NAGPRA needs.

U.S. FISH AND WILDLIFE SERVICE – The USFWS compiled inventory data to satisfy the requirements of Sections 5 and 6 of the NAGPRA in 1996. The USFWS continues to improve its accountability for newly identified cultural items located in museum collections and under the control of the USFWS; or, for those items forfeited to the USFWS as part of law enforcement activities (pursuant to the Future Applicability Rule (43 CFR 10.13). Work is necessary to examine USFWS legacy collections—those that are part of unaccessioned and uncataloged collections, most of which are in non-federal museums – which still lack basic information on their origin, location and affiliation, if any, under NAGPRA.

Recommendation 2. *The Secretary of the Interior should direct the cultural resource management programs to develop and provide to Congress a timetable for the expeditious publication in the Federal Register of notices of inventory completion for all remaining Native American remains and associated funerary objects that have been culturally affiliated in inventories.*

To address this recommendation, each DOI bureau and office that has inventoried and determined the cultural affiliation of Native American cultural items in their collections, but not published in Notices of Inventory Completion in the *Federal Register*, prepared a timetable for the expeditious publication of notices. The following table presents the timeline for each DOI bureau and office to publish these notices.
