Subject: Designation of 5 Properties as National Historic Landmarks, Acceptance of Updated Documentation for 9 National Historic Landmarks, and Withdrawal of Designation for 2 National Historic Landmarks: Director's Recommendation and Request for Secretarial Action

At its meeting on May 1-2, 2024, the National Park System Advisory Board recommended the designation of the following properties as National Historic Landmarks:

1. LATTE QUARRY AT AS NIEVES, Rota, CNMI (Criteria 4 and 6)
2. THE FURIES COLLECTIVE, Washington, DC (Criterion 1)
3. BIG BONE LICK SITE, Union, KY (Criterion 1)
4. KREGEL WINDMILL COMPANY FACTORY, Nebraska City, NE (Criterion 1)
5. CHARLESTON CIGAR FACTORY, Charleston, SC (Criterion 1)

In accordance with National Historic Landmarks Program regulations, the Board reviewed the study nominating these five properties for Landmark status and found that this property meets National Historic Landmarks Program criteria. The Board, therefore, voted to recommend that these properties be designated as National Historic Landmarks.

Also, at its meeting on May 1-2, 2024, the National Park System Advisory Board recommended acceptance of updated documentation for the following existing National Historic Landmarks:

1. SITKA NAVAL OPERATING BASE AND U.S. ARMY COASTAL DEFENSES, Sitka, AK (Criterion 1)
2. LADD FIELD, Fairbanks, AK (Criterion 1, Criteria Exception 2)

3. PU'UKOHOLĀ HEIAU, Kawaihae, HI (Criteria 1, 2, 4, and 6)
4. CALUMET HISTORIC DISTRICT, Calumet, MI (Criteria 1 and 5)
5. QUINCY MINING COMPANY HISTORIC DISTRICT, Houghton County, MI (Criteria 1 and 5)
6. WATKINS MILL, Lawson, MO (Criterion 1)
7. FORT BROWN, Brownsville, TX (Criterion 1, Criteria Exception 2)
8. CEDAR CREEK BATTLEFIELD AND BELLE GROVE PLANTATION, Middletown, VA (Criteria 1 and 5)
9. WYOMING STATE CAPITOL BUILDING AND GROUNDS, Cheyenne, WY (Criteria 1 and 3)

In accordance with National Historic Landmarks Program regulations, the Board reviewed the updated documentation reports for these Landmarks and found that the updated documentation meets National Historic Landmarks Program criteria. The Board, therefore, voted to recommend that the updated documentation for these nine National Historic Landmarks be accepted.

Also, at its meeting on May 1-2, 2024, the National Park System Advisory Board recommended withdrawal of designation for the following existing National Historic Landmarks:

1. JOSEPHUS DANIELS HOUSE (WAKESTONE), Raleigh, NC
2. *USS CLAMAGORE* (former), Mount Pleasant, SC

In accordance with National Historic Landmarks Program regulations, the Board reviewed the withdrawal of designation reports for these Landmarks and found that these properties no longer meet National Historic Landmarks Program criteria. The Board, therefore, voted to recommend that designation for these two National Historic Landmarks be withdrawn.


I recommend that you approve the Board's May 1-2, 2024, recommendations and designate as a National Historic Landmarks the five properties listed above, accept the updated documentation
