HISTORY

After the Yellowstone Park Company lost its contract with the government in 1979, the National Park Service awarded TWA Services, Inc. an interim contract for two years to operate Yellowstone National Park's concessions. The company operated the lodging and dining accommodations, transportation, boats and saddle horses within the park, in addition to running the park service stations with Hamilton Stores, Inc. At the end of TWA Services' interim contract, in 1981, the National Park Service extended the company's contract for another five years, choosing TWA Services over seven other firms that submitted proposals for the right to run Yellowstone's concessions. By then, TWA Services had provided fifty years worth of concession services with the National Park Service, serving in other parks such as Zion, Crater Lake, and the North Rim of the Grand Canyon. In 1984, the company changed its name to TW Services, Inc. and, in 1988, changed its name again to TW Recreational Services, Inc.

In 1995, TW Recreational Services was purchased by Amfac Parks and Resorts. Amfac began in the 1960s managing resorts in Hawaii until it acquired the Fred Harvey Company in 1968. Through the Fred Harvey Company, Amfac's business expanded to hotels and restaurants in the southwest. With the acquisition of TW Recreational Services, Amfac became the largest concessioner in the national and state park systems. In 2002, Amfac Parks and Resorts changed its name to Xanterra Parks and Resorts to better reflect the goals and responsibilities of the company. Through 2012, the company continues to be the main concessioner at Yellowstone National Park.

<i>DESCRIPTION</i>	<p>This collection contains business records, employee materials, training manuals, directories, and ephemera from Xanterra Parks and Resorts, a concessioner of Yellowstone National Park.</p> <p>This collection consists of materials collected by archives staff as well as items donated by former employees of Xanterra and TW Recreational Services, and includes personnel records, programs, media, and business records. The collection primarily reflects the public aspects of Xanterra through the programs and services provided to visitors and employees. The business records consist of records and correspondence that relate to transportation concerns, memos, reports, meeting notes, and budgetary documentation. The personnel materials consist of records of employee activities, including hiring packets, yearbooks, newsletters, telephone directories, and training manuals. The public programs series contains flyers and records of programs put on by Xanterra, including reports, evaluations, manuals, and booklets for children's programs, and records and flyers for commemorative events. The media series contains a collection of menus and brochures of park accommodations.</p>
<i>ORGANIZATION</i>	<p>The collection is organized into four series: Series I, Business Records; Series II, Personnel; Series III, Public Programs; Series IV, Media.</p> <p>Series IV, Media is divided into two sub-series: Sub-Series A, Brochures and Publications; Sub-Series B, Menus.</p>
<i>PROVENANCE</i>	This is an artificial collection created to document Xanterra

Parks and Resorts at Yellowstone National Park. The materials and records of this collection were collected by former employees of Xanterra and HRC staff. Xanterra Parks and Resorts, as a corporation, has its own records keeping program.

SERIES DESCRIPTIONS

I. Business Records, 1980-2006

This series mostly consists of correspondence, petitions, rates and regulations relating to transportation concerns, primarily with the Public Service Commission of Montana and Wyoming. Other materials in this series consist of managers' meetings notes, memos on the company name change from Amfac to Xanterra, employee statistics, evaluation reports of accommodations, and budget documentation.

II. Personnel, 1980-2007

This series contains materials relating to employees and their activities, including telephone directories, employee publications, training manuals, yearbooks, newsletters, hiring and orientation packets, and an interpretive tour booklet.

III. Public Programs, 1997-2004

This series consists of booklets, a manual, evaluations, reports, correspondence, press releases, scripts, and flyers for Xanterra sponsored public programs that include commemorative events, dedications, weekend events, and children's programs.

IV. Media, 1980-2010

This series is composed of media created by Xanterra and is divided into sub-series based on format. It contains brochures and publications ranging from 1993 to 2002, with information and rates for park accommodations and activities, along with general information about the park and its geographic features. There are also menus collected from 1980 to present, from the various Xanterra dining accommodations at the park.
